That on the 5th day of January, 1995, said Contractor made a subcontract with the Claimant to provide all labor and materials necessary to install all electric on the premises for and in said improvement, and that, on the 15th day of June, 1998 the Claimant completed thereunder (2) all work that was required to be done under the contract.

That, at the special instance and request of said Contractor, the Claimant furnished extra and additional materials at and extra and additional labor on said premises of the value of \$800.00 as fully set forth in an account and did complete the same on the 15th day of June, 1998.

That neither said owner, nor his agent, architect or superintendent can, upon reasonable diligence, be found in said County so as to serve upon either of them personally a notice hereof in accordance with the statute in such cases made and provided.

That said Contractor entitled to credits on account thereof as follows: \$0, leaving due, unpaid and owing to the Claimant, after allowing all credits, the sum of \$25,600.00 for which, with interest, the Claimant claim a lien on said land and improvements, against said Contractor and owner.
