

BALLOON LOAN MODIFICATION
(Pursuant to the Terms of the Balloon Note Addendum and Balloon Rider)

(1) This Balloon Loan Modification ("Modification"), entered into effective as of the 1st day of APRIL, 1998, between BARRY ALLEN AYNESSAZIAN AND COLLEEN R. AYNESSAZIAN, "Borrower") and Flagstar Bank, FSK, formerly known as First Security Savings Bank ("Lender"), amends and supplements (1) the Mortgage, Deed of Trust or Deed to Secure Debt (the "Security Instrument"), dated MARCH 23, 1992, securing the original principal sum of U.S. \$134,000.00, and recorded in Liber/Book/Document/Volume/Reel/Deed Book # 93252294, COOK, County Records of the STATE OF ILLINOIS, and

(2) the Balloon Note bearing the same date as, and secured by, the Security Instrument (the "Note") which covers the real and personal property described in the Security Instrument and defined in the Security Instrument as the "Property", located at: 1912 SOUTH VINE AVENUE, PARK RIDGE, ILLINOIS 60068, the real property being described being set forth as follows:

LOT 12 IN BLOCK 13 AND THE EAST 1/4 OF THE VACATED ALLEY LYING WEST AND ADJOINING KINSEY'S PARK RIDGE SUBDIVISION OF PART OF SECTIONS 1 AND 2, TOWNSHIP 40 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

Commonly known as: 1912 SOUTH VINE AVENUE

To evidence the election by the Borrower of the Conditional Right to Refinance, conditional Modification, and Extension of Loan Terms as provided in the Balloon Note Addendum and Balloon Rider and to modify the terms of the Note and Security Instrument in accordance with such election, Borrower and Lender agree as follows (not withstanding anything to contrary contained in the Note or Security Instrument):

1. The Borrower is the owner and occupant of the Property.
2. As of APRIL 1, 1998, the amount payable under the Note and Security Instrument (the Unpaid Principal Balance) is U.S. \$125,405.83.
3. The Borrower promises to pay the Unpaid Principal Balance, plus interest, to the order of the Lender. Interest will be charged on the Unpaid Principal Balance at yearly rate of 7.625%, beginning APRIL 1, 1998. The Borrower promises to make monthly payments principal and interest of U.S. \$936.96, beginning on the 1st day of MAY 1, 1998, and continuing thereafter on the same day of each succeeding month until principal and interest are paid in full. If on APRIL 1, 2023 (the Modified Maturity Date), the Borrower still owes amounts under the Note and the Security Instrument, as amended by this Modification, the Borrower will pay these amounts in full on the Modified Maturity Date.

The Borrower will make such payments at Flagstar Bank or at such other place as the Lender may require.

The Borrower will comply with all other covenants, agreements, and requirements of the Note and the Security Instrument, including without limitation, the Borrower's covenants and agreements to make all payments of taxes, insurance premiums, assessments, escrow items, impounds, and all other payments that the Borrower is obligated to make under the Security Instrument; however, all the terms and provisions of the Balloon Note Addendum and Balloon Rider are forever canceled, null and void, as of the maturity date of the Note.

5. Nothing in this Modification shall be understood or construed to be a satisfaction or release in whole or in part of the Note and Security Instrument. Except as otherwise specifically provided in this Modification, the Note and Security Instrument will remain unchanged and in full effect, and the Borrower and Lender will be bound by, and comply with, all of the terms and provisions thereof, as amended by this Modification.
