

SEVENTH AMENDMENT TO
DECLARATION OF CONDOMINIUM
PURSUANT TO THE CONDOMINIUM PROPERTY ACT OF
THE TUXEDO PARK CONDOMINIUM

WHEREAS, Owner is the owner in fee simple of the Additional Parcel (as defined in the Declaration); and

WHEREAS, the Owner wishes to annex and add a portion of the Additional Parcel to the Parcel (as defined in the Declaration) and the Property (as defined in the Declaration) pursuant to the terms of Paragraph 27 of the Declaration; and

WHEREAS, the Owner wishes to modify pages 1 and add page 8 to Exhibit E to the Declaration;

NOW Therefore, the Declaration as amended by the First Amendment, the Second Amendment, the Third Amendment, the Fourth Amendment, Fifth Amendment and Sixth Amendment is hereby further amended as follows:
