above entitled matter is hereby vacated and held for naught.

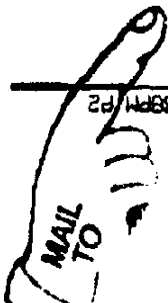
IT IS FURTHER ORDERED that the above entitled matter be and the same is hereby dismissed.
