The Illinois Environmental Protection Agency ("Illinois  $E^{\rho}A$ ") has reviewed the Corrective Action Completion Report Area F124 - Tank 124-1 which has oeen submitted for the abovereferenced LUST incident. This information was dated May 12, 1998 (revision 2), was received by the Agency May 19, 1998, and was prepared by Morrison Knudsen Corporation.

The Corrective Action Completion Report and the Professional Engineer Certification submitted pursuant to 35 Illinois Administrative Code Section 731 indicate that the remediation has been successfully completed.

Based upon (a) the certification by Gordon Gear, a Registered Professional Engineer of Minois, (b) the certification by CDR Scott Hayward/Navy Caretaker Site Office/SOUTHDIV, the owner and operator of the underground storage tank(s), and based upon other information in the Agency's possession, your request for a no further remediaiton determination is granted under the conditions and terms specified in this letter.

Issuance of this No Further Remediation Letter (Letter), based on the certification of the Registered Professional Engineer signifies that: (1) all statutory and regulatory corrective action requirements applicable to the occurrence have been complied with; (2) all corrective action concerning the occurrence has been completed; and (3) no further remediation concerning the occurrence is necessary for the protection of human health, safety and the environment. Pursuant to Section 57.10(d) of the Act, the No Further Remediation Letter shall apply in favor of the following persons:

- 1. Mr. David Smith;
- 2. The owner and operator of the UST(s);
- 3. Any parent corporation or subsidiary of the owner or operator of the UST(s);
- 4. Any co-owner of co-operator, either by joint-tenancy, right of survivorship, or any other party sharing a legal relationship with the owner or operator to whom the letter is issued;
- 5. Any holder create beneficial interest of a land trust or intervivos trust, whether revocable or irrevocable;
- 6. Any mortgagee or trustee of a deed of trust of the owner of the site or any assignee, transferee, or any successor-in-interest of the owner of the site;

- 8. Any transferee of such owner or operace whether the transfer was by sale, bankruptcy proceeding, partition, dissolution of marriage, settlement or adjudication of any civil action, charitable gift, or bequest; or
- 9. Any heir or devisee of such owner or operator.

This Letter, including all attachments, must be filed as a single instrument with the Office of the Recorder or Registrar of Titles in the County where the above-referenced site is located within 45 days of its receipt. 




