ORDINANCE NO. 98-560

AN ORDINANCE GRANTING A ZONING VARIANCE FOR PROPERTY LOCATED AT 11656 MERRION LANE

WHEREAS, the Planning, Zoning and Development Commission of the Village of Merrionette Park has considered granting a variation in the zoning requirements pertaining to the parcel of real property located at 11656 Merrion Lane, on which there is a single-family residence; and

WHEREAS, the Commission duly held a hearing on the proposed variation; and

WHEREAS, the Commission recommended that a variation be granted, and the Board of Trustees has concurred in that recommendation;

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MERRIONETTE PARK, COOK COUNTY, ILLINOIS, AS FOLLOWS:

Section 1. Variance Granted. The owner of the real property situated in the Village of Merrionette Park, Cook County, Illinois, legally described as follows:

Lot 22 in Merrionette Park Subdivision, being a subdivision of part of the east 1/2 of the southeast quarter of Section 23, Township 37, Range 13 east of the Third Principal Meridian in Cook County, Illinois.

Address: 11656 Merrion Lane, Merrionette Park, IL 60203

PIN # 24-23-409-031-0000

is hereby granted a variance from the Village Code in accordance with the petitioner's application and pursuant to the recommendations of the Planning, Zoning and Development Commission, to construct a 30' 9" x 8' deck, one foot high, starting at the side entrance of the house and wrapping around to the front of the house.

Section 2. Findings. The Board finds that this variation is in harmony with the general purpose and intent of the village zoning regulations; that the plight of the owner is due to unique circumstances; that there are practical

difficulties and particular hardship in carrying out the requirements of the regulations on this property and that the variation does not alter the essential character of the locality.

Section 3.

Time Limit for Construction. If construction of the deck is not completed within one year from the date of approval of this ordinance, this variation shall be automatically withdrawn, and ordinance automatically repealed.

Section 4.

Recording. The Village Attorney is directed and authorized to record a certified copy of this ordinance with the Recorder of Deeds of Cook County.

Section 5.

Fffective Date. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.

Unless Lender and Borrower otherwise agree in writing, insurance proceeds shall be applied to restoration or repair of the Property damaged, provided such restoration or repair is economically feasible and the security of this Mortgage is not thereby impaired. If such restoration or repair is not economically feasible or if the security of this Mortgage would be impaired, the insurance proceeds shall be applied to the sums secured by this Mortgage, with the excess, if any, paid to Borrower. - Borrower Not Released. Extension of the time for payment or modification of amortization of the sums secured by this Mortgage or any other term of the Agreement or this Mortgage granted by Lender to any successor in interest of Borrower shall not operate to release, in any manner, the liability of the original Borrower and Borrower's successors in interest. assessments, or insurance on the Property and interest on such disbursements (all such indebtedness being hereinafter referred to as the "maximum amount secured hereby"). This Mortgage shall be valid and have priority over all subsequent liens and encumbrances, including statutory liens, excepting solely taxes and assessments levied on the Property, to the extent of the maximum amount secured hereby.

- Termination and Acceleration. Lender shall give notice to Borrower prior to acceleration following Borrower's breach specifying (a) the default (b) the action require to cure the default (c) a date (not less than thirty days from the date notice is given to the Borrower) by which the default must be cured and (d) that failure to cure the default on or before the date specified in the notice may result in acceleration of the sums secured by this Mortgage, foreclosure by judicial proceeding or by advertisement and sale of the Property. If the default is not cured by the date specified in the notice, Lender at its option may require immediate payment in full of all sums secured by this Mortgage without further demand and may foreclose this Mortgage by judicial proceeding or by advertisement. If it becomes necessary to enforce or foreclose this mirritage including by judicial proceeding or by advertisement, Lender shall be entitled to collect all expenses of collection, enforcement and foreclosure, including but not limited to reasonable attorneys' fees, court costs and costs of documentary evidence abstracts and title reports. Lender is authorized and empowered to grant, bargain and sell, release and convey the Property at public venue and to execute and deliver to the purchasers at such sale good and sufficient deeds of conveyance in law, pursuant to statute.
- Assignment of Rents; Appointment of Receiver; Lender in ossession. As additional security hereunder, Borrower hereby assigns to Lender the rents of the Property, provided that Borrower shall, prior to acceleration under paragraph 17 hereof or abandonment of the Property, have the right to collect and retain such rents as they become due and payable.

Upon acceleration under paragraph 17 bereof or abandonment of the Property, and at any time prior to the expiration of any period of redemption following judicial sale, Lender, in person, by agent or by judicially appointed receiver, shall be entitled to enter upon, take possession of and manage the Property and to collect the rents of the Property including those past due. All rents collected by Lender or the receiver shall be applied first to payment of the costs of management of the Property and collection of rents, including, but not limited to receiver's fees, premiums on receiver's bonds and reasonable attorneys' fees, and then to use stands secured by this Mortgage. Lender and the receiver shall be liable to account only for those rents actually received.

Release. Upon payment of all sums secured by this Mortgage and termination of the Agreement, Lender shall release this Mortgage. To the full extent allowed by the provisions of applicable law, Borrower hereby waives any and all rights of redemption from sale under any order of foreclosure of this Mortgage on behalf of the Borrower, the Borrower's estate and all persons beneficially interested therein.
