- 3. Said Assessment Roll and Report and all proceeding: herein are confirmed and judgment of confirmation is hereby entered against each lot, tract and parcel of land as described in and for the amount set forth in said Assessment Roll and Report as returned by the Commissioner and filed herein and for each installment.
- 4. That said Assessment Roll and Report as confirmed be certified by the Clerk of this Court to the Clerk of the Village of Palos Park, Cook County, Illinois, as required by law.
