If the resulting rate is 050/1000 not a multiple of one-eighth of one percentage point (0.125%), the Note Holder will then round the result of the calculation to the next higher one-eighth of one percentage point (0.125%). Subject to the limits stated in Section 4(D) below, this rounded amount will be my new interest rate until the next Change Date.

(D) Limits of Interest Rate Changes

The interest rate I am required to pay at the first Change Date will not be greater than 10.60000 % or less than the initial interest rate. Thereafter, my interest rate will never be increased or decreased on any single Change Date by more than one percentage point (1%) from the rate of interest I have been paying for the preceding six months. My interest rate will never be greater than 15.60000 %. My interest rate will never be less than the initial interest rate.
