CLAIM FOR MECHANICS LIEN

Claimant, INTERSTATE ELECTRONICS COMPANY of 7615 Plaza Court, Willowbrook, DuPage County, Illinois hereby makes and files this claim for a mechanic's lien against HAZLETT & RAIRIGH CONSTRUCTION MANAGEMENT, INC., contractor, of Evanston, Cook County, Illinois, and FAITH TEMPLE, CHURCH OF GOD IN CHRIST AT EVANSTON (hereinafter referred to as "owner") of Evanston, Cook County, Illinois, and any persons claiming to be interested in the real estate herein, and states:

1. That on August 15, 1997, the owner owned the following described land in Cook County, Illinois, to-wit: Legal description as set forth in Exhibit A; commonly known as 1932 Dewey Avenue, Evanston, Illinois.
2. That prior to August 15, 1997, the owner had entered into a contract with HAZLETT & RAIRIGH CONSTRUCTION MANAGEMENT, INC. for the improvement of said land.
3. That on August 15, 1997, said contractor entered into a subcontract with the Claimant to provide and furnish all labor, materials, tools, equipment, vehicles, accessories, supervision, services and supplies to provide and furnish electrical work for Faith Temple Church sound and related systems.
4. That on April 25, 1998, the Claimant completed thereunder all required by said contract to be done, labor and materials and supplies to the value of Thirty Nine Thousand Five Hundred Dollars (\$39,500.00).
5. That there is now due, owing, and unpaid to Claimant, after allowing to Contractor all credits to which Contractor is entitled, the sum of Thirty Nine Thousand Five Hundred Dollars (\$39,500.00), for which, with interest, Claimant claims a lien on said land and improvements thereto and on the moneys or other consideration due or to become due from the owner under said contract against said contractor and owner.

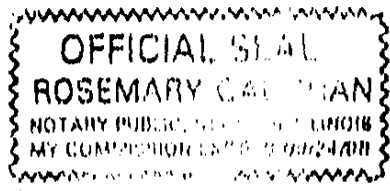
