BORROWER COVENANTS that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property and that the Property is unencumbered, except for encumbrances of record. Amreasonably withheld. If Borrower fails to maintain coverage described above, Lender may, at Lender's option, obtain coverage to approtect Lender's rights in the Property in accordance with paragraph 7.
