16. **Borrower's Copy.** Borrower shall be given one conformed copy of the Note and of this Security Instrument.

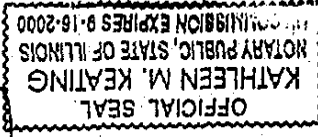
