SECOND CREDIT LINE MODIFICATION AGREEMENT CONTROL OF THE SECOND CREDIT CR

WHEREAS, Citizens Financial Services, FSB, formerly known as Citizens Federal Savings and Loan Association of Hammond, Indiana (Lender) granted a revolving line of credit to Lansing Sportsman's Club, an Illinois Corporation d/b/a Lansing Country Club, Inc., an Illinois Not-for-Profit Corporation (Borrower), Mercantile National Bank of Indiana, a National Banking Association, as Trustee under a certain Trust Agreement, dated the 11th day of October, 1972, and known as Trust No. 2984 (Indiana Trustee Mortgagor) and First National Bank of Illinois, as Trustee under the provisions of a certain Trust Agreement, dated the 3rd day of October, 1980 and known as Trust No. 3174 (Illinois Trustee Mortgagor) with a credit limit of Forty Thousand Dollars (\$40,000.00) as evidenced by a Line of Credit/Variable Interest Rate Promissory Note and Line of Credit Agreement (Note and Agreement) executed on December 8, 1986;

WHEREAS, to secure the repayment of the Note and Agreement, Borrower and Indiana Trustee Mortgagor executed and delivered to Longer a Real Estate Mortgage (Indiana Mortgage) dated December 11, 1986, which Indiana Mortgage was recorded in the Office of the Recorder of Lake County, Indiana on December 18, 1986 as Document No. 892125 and re-recorded on December 31, 1986 as Document No. 894092, which Indiana Mortgage affects the real estate as described on the attached Exhibit "B";

WHEREAS, Borrower sold Parcel 1 described on the attached Exhibit "A" and Lender released that parcel from collateral on July 25, 1991;

WHEREAS, said Note and Agreement, the Illinois Mortgage and the Indiana Mortgage were subsequently modified by a Line of Credit Modification Agreement (First Modification) dated November 30, 1994, which modification was recorded in the Office of the Recorder of Lake County, Indiana as Document No. 94087105 and in the Office of the Recorder of Cook County, Illinois as Document No. 04021099;

WHEREAS, the Note and Agreement, the Illinois Mortgage, the Indiana Mortgage and the First Modification are hereby incorporated herein as part of this Second Line of Credit Modification Agreement (Agreement);

WHEREAS, Borrower has requested a second modification of the terms of said line of credit for the purpose of increasing the credit limit from One Hundred Forty Thousand Dollars (\$140,000.00) to Two Hundred Fifty Thousand Dollars (\$250,000.00);
