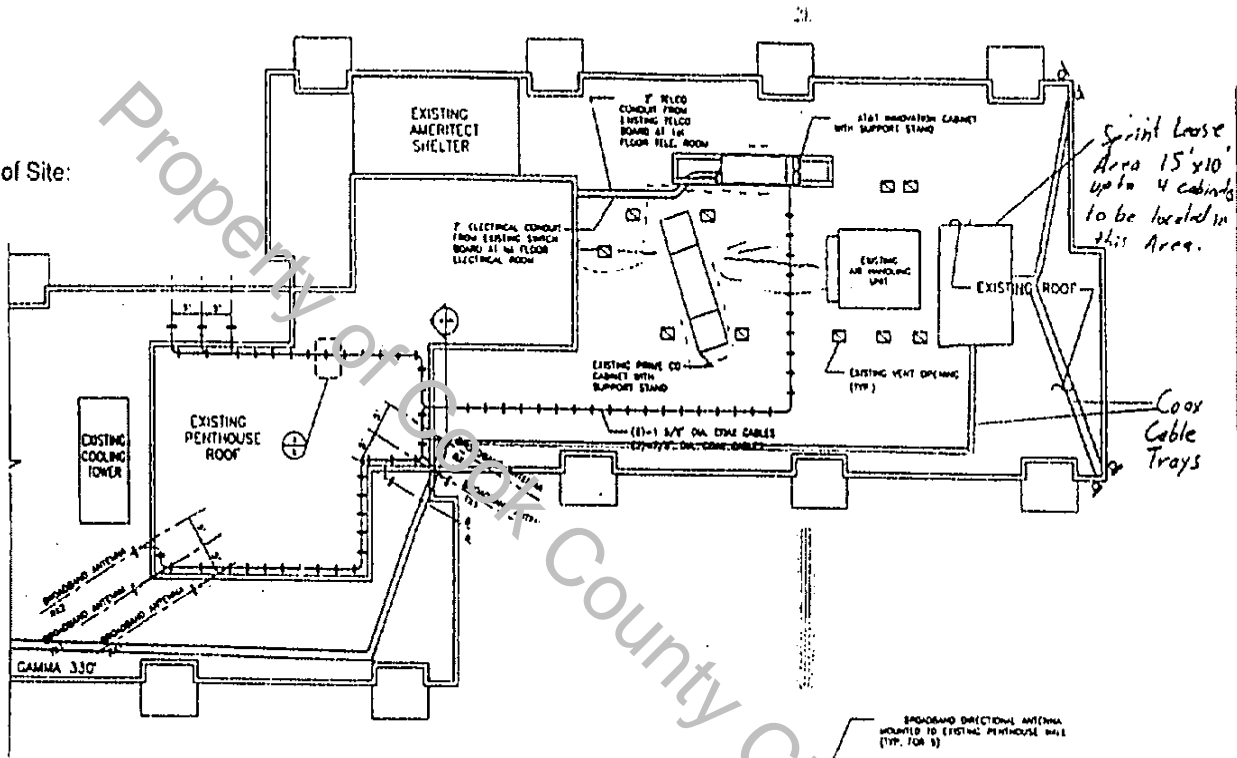

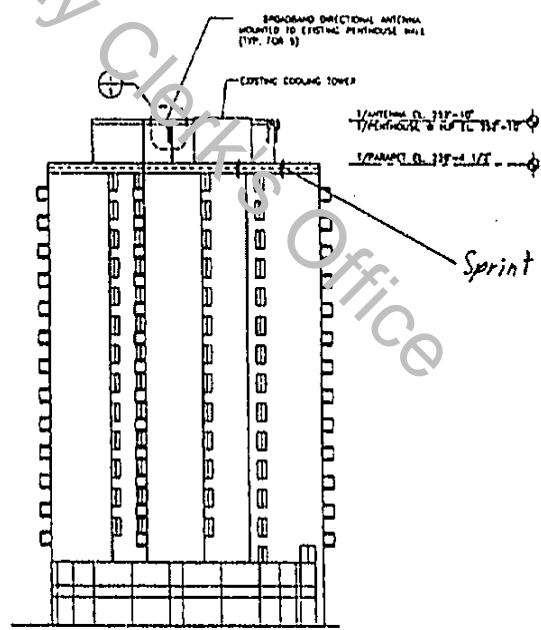
Sketch of Site:

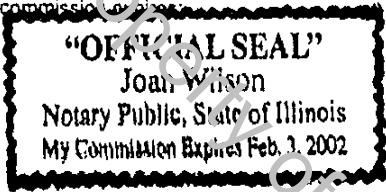



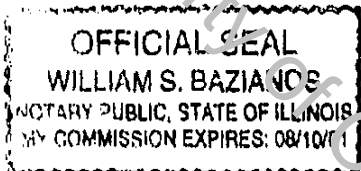
