MODIFICATION AGREEMENT (Mortgage)

This Modification Agreement is effective as of this 30th day of June, 1998, between MID-CITY PARKING, INC., an Illinois corporation (hereinafter referred to as "Mortgagor") and AMERICAN NATIONAL EARK AND TRUST COMPANY OF CHICAGO (hereinafter referred to as "Mortgagee").

This new note and the Original Note are collectively referred to hereinafter as the "Note", with such other amendments, modifications, extensions, renewals or replacements thereof, and

WHEREAS, the parties hereto have agreed upon a modification of the terms and conditions of the Mortgage as herein set forth; and

NOW THEREFORE, in consideration of the premises and the mutual promises and agreements hereinafter made by and between the parties hereto, the said parties do hereby mutually agree to modify the Mortgage as follows:

1. The principal amount of the Mortgage is hereby amended to \$1,054,181.08.

- 3. All terms used herein and not otherwise defined shall have the respective meanings set forth in the Note and Mortgage.
- This Modification shall be incorporated into and made a part of the Mortgage and 4. Note, as amended, and all other related loan documents executed by Mortgagor.
- 5. Mortgagor hereby agrees to execute and deliver, or cause to be executed and delivered, to Mortgagee such additional documentation as Mortgagee shall require in order to evidence or effectuate the transactions contemplated hereby or in order to update information and undertakings heretofore given to Mortgagee by or on behalf of Mor gager.
- This Modification shall be governed by, and construed in accordance with, the 7. internal laws of the State of Viinois.
- 8. This Modification shall inure to the benefic of Mortgagee's successors and assigns, and shall be binding upon the successors and assigns of Mortgagor.
