## CONSTRUCTION MORTGAGE, SECURITY AGREEMENT AND ASSIGNMENT OF LEASES AND RENTALS

THIS CONSTRUCTION MORTGAGE, SECURITY AGREEMENT AND ASSIGNMENT OF LEASES AND RENTALS is made the 2rd day of July, 1998 by 252 Walden Development Company, L. L.C., an Illinois limited liability company (I crein called the "Mortgagor"), to THE FIRST NATIONAL BANK OF CHICAGO (the "Mortgagoe"), a national banking association, organized and existing under the laws of the United States of America, having its principal office at One First National Plaza, Chicago, Illinois 60670.

#### WITNESSETH:

Together with, all easements, rights-of-way and rights pertaining thereto or as a means of access thereto, and all tenements, hereditaments and appurtenances thereof and thereto;

Together with, any and all buildings and improvements now or hereafter erected thereon, including, but not limited to, the fixtures, attachments, appliances, equipment, machinery, and other articles attached to said buildings and improvements; and

Mortgagor represents that it has good right and full power to sell and convey the same and that it has duly executed and delivered this Mortgage pursuant to proper directions and that Mortgagor will make any further assurances of title that the Mortgage may require and will defend the Property against all claims and demands whatsoever.
- 2.02 Mortgagor represents that the proceeds of the loan evidenced by the Note will be used for the purposes specified in 815 ILCS 205/4 and that the principal sum evidenced by the Note constitutes a business loan which comes within the purview of such paragraph
- 2.03 Neither Mortgagor nor, to the best of Mortgagor's knowledge, any previous owner of the Property or any third party, has used, generated, stored or disposed of pay Hazardous Substances on the Property. For the purposes of this representation and warranty, Hazardous Substances shall include, but shall not be limited to, any toxic or hazardous wastes, pollutants or substances, including, without limitation, ashestos, PCBs, petroleum products and by-products, substances defined or listed as hazardou, substances or toxic substances or similarly identified in or pursuant to the Comprehensive Environmental Resporse, Compensation and Liability Act of 1980, as amended, 42 U.S.C. á 9601 et seq., hazardous materials identified in or pursuant to the Hazardous Materials Transportation Act, 49 U.S.C. à 1802 et seq., hazardous wastes identified in or pursuant to The Resource Conservation and Recovery Act, 42 U.S.C. a 6901 et seq., any chemical substance or mixture regulated under the Toxic Substance Control Act of 1976, as amended, 15 U.S.C. á 2601 et eq., any toxic pollutant under the Clean Water Act, as amended, 33 U.S.C. á 1251 et seq., any hazardous air polluta it in der the Clean Air Act, 42 U.S.C. à 7401 et seq., and any hazardous or toxic substance or pollutant regulated una cany other applicable federal, state or local environmental health or safety laws, regulations or rules of common lays. Mortgagor shall indemnify and hold Mortgagee harmless from and against all liability, including all foresceable and unforesceable consequential damages, directly or indirectly arising out of the use, generation, storage or dispesso of Hazardous Substances, including without limitation, the cost of any required or necessary repair, clean-up or detoxification and the preparation of any closure or other required plans, whether such action is required or necessary prior to or following transfer of title to the Property, to the full extent that such action is attributable, directly or indirectly, to the use, generation, storage or disposal of Hazardous Substances on the Property.

### ARTICLE III WAIVER OF REDEMPTION

3.01 Mortgagor acknowledges that the Real Estate does not constitute agricultural real estate as said term is defined in Section 15-1201 of the Illinois Mortgage Foreclosure Law (the "Act") or residential real estate as defined in Section 15-1219 of the Act. Mortgagor hereby waives any and all rights of redemption under judgment of foreclosure of this Mortgage on behalf of Mortgagor, and on behalf of each and every person acquiring any interest in or title to the Real Estate or of any nature whatsoever subsequent to the date of this

Mortgage. The foregoing waiver of right of redemption is made pursuant to the provisions of Section 15-160(B) of the Act. To the fullest extent permitted under applicable law, Mortgagor shall not, and will not, apply for or avail itself of any appraisement, valuation, stay, extension or exemption law, or so-called "Moratorium Laws," now existing or hereafter enacted, in order to prevent or hinder the enforcement or foreclosure of this Mortgage, but hereby waives the benefit of such laws. Mortgagor for itself and all who may claim through or under it waives any and all right to have the Real Estate, and any estates comprising the Real Estate, marshalled upon any foreclosure of the lien hereof and agrees that any court having jurisdiction to foreclose such lien may order the Real Estate sold as an entirety.

## ARTICLE IV MORTGAGOR'S COVENANTS

- 4.01 Mortgagor covenants and agrees to pay the Indebtedness and the other sums secured hereby in the manner and at the times provided for in the Loan Documents.
  - 4.02 Mortgagor covenants and agrees to pay, or cause to be paid, when due and payable by Mortgagor:

- 4.03 To assure payment of Taxes and insurance premainos payable with respect to the Property as and when the same shall become due and payable:
  - (a) The Mortgagor shall deposit with Mortgagee at the time of the disbursement of the proceeds of the Note:
  - (i) An amount equal to one-twelfth of such Taxes due multiplied by the number of months (plus one additional month) clapsed between the date on which the most recent installment for such taxes was required to be paid and the date of such first deposit; and
  - (ii) An amount equal to one-twelfth of such annual insurance premiums multiplied by the number of months (plus one additional month) elapsed between the date premiums on each policy were last paid to and the date of such first deposit.
  - (b) Concurrently with each monthly payment installment pursuant to the Note, Mortgagor shall deposit with Mortgagee an amount equal to nine (9%) percent of the last ascertainable bills for Taxes and insurance premiums.
  - (c) The amount of such deposits ("Tax and Insurance Deposits") shall be based upon the most recently available bills therefor. All Tax and Insurance Deposits shall be held by the Mortgagee without any allowance of interest thereon.
  - (d) Monthly Tax and Insurance Deposits, together with monthly payments of principal, if any, and interest shall be paid in a single payment each month, to be applied to the following items in the following order:

- (e) Mortgagee will pay insurance premiums and Taxes from the Tax and Insurance Deposits upon the presentation by Mortgagor of bills therefor, or upon presentation of receipted bills, reimburse Mortgagor for such payments

If the total Tax and Insurance Deposits on hand are not sufficient to pay all of the Taxes and insurance premiums when due, Mortgagor will deposit with Mortgagee any amount necessary to make up the deficiency. If the total of such deposits exceeds the amount required to pay Taxes and insurance premiums, such excess shall be credited on subsequent deposits to be made for such items.

of: In the event of a default in any of the provisions of this Mortgage or the Note, Mortgagee may, but shall not be required to, apply Tax and Insurance Deposits on any Indebtedness, in such order and manner as Mortgage, may elect. When the Indebtedness has been fully paid, any remaining Tax and Insurance Deposits shall be paid to Mortgagor.

All Tax and Insurvoce Deposits are hereby pledged as additional security for the Indebtedness and shall not be subject to the directic or control of the Mortgagor.

- (g) Mortgagee their not be liable for any failure to apply any amounts deposited to the payment of Taxes and insurance premiums unless while no default exists hereunder Mortgagor shall have presented to Mortgagoe the appropriate Tax and incurance premium bills to be paid from the Tax and Insurance Deposits.
- 4.04 Mortgagot covenants and agrees to keep and maintain, or cause to be kept and maintained, the Property (including all improvements thereon call the sidewalks, sewers, and curbs) in good order and condition and will make or cause to be made, as and when the tame shall become necessary, all structural and nonstructural, ordinary and extraordinary, foreseen and unforceen repairs and all maintenance necessary to that end. Furthermore, and without limiting the generality of the foregoing, Mortgagor will suffer no waste. All repairs and maintenance required of Mortgagor shall be (in the reasonable opinion of Mortgagoe) of first-class quality.
- 4.05 Mortgagor covenants and agrees that this Mortgage is and will be maintained as a valid mortgage lien on the Property and that Mortgagor will not, directly or indirectly, create or suffer or permit to be created, or to stand against the Property, or any portion thereof, or against the rints, issues and profits therefrom, any lien (including any tiens arising with respect to the payment of Taxes), sociality interest, encumbrance or charge whether prior to or subordinate to the lien of this Mortgage unless witten approval is first obtained from Mortgagee. Mortgagor will keep and maintain the Property free from all liens of persons supplying labor and materials for the construction, modification, repair or maintenance of any building or site improvement whether on the Property or not
- 4.06 Mortgagor covenants and agrees, so long as the Indebtedness remains outstracting, to comply with all regulations, rules, ordinances, statutes, orders and decrees of any governmental authority or court applicable to the Mortgagor or applicable to the Property or any part thereof and will promptly cure any violation of law and comply with any order of any such governmental authority or court in respect of the repair, replacement or condition of the Property and any governmental regulations concerning environmental control and improvements.
- 4.07 Mortgagor covenants and agrees that all awards heretofore or hereafter made by any public or quasi-public authority to the present and all subsequent owners of the Property by virtue of an exercise of the right of eminent domain by such authority, including any award for a taking of title, possession or right of access to a public way, or for any change of grade of streets affecting the Property, are hereby assigned to the Mortgagoe.
- 4.08 Mortgagor covenants and agrees that neither the value of the Property nor the lien of this Mortgage will be diminished or impaired in any way by any act or omission of the Mortgagor, and the Mortgagor agrees it will not do or permit to be done to, in, upon or about said Property, or any part thereof, anything that may in any wise impair the value thereof, or weaken, diminish, or impair the security of this Mortgage.

- 4.09 Mortgagor covenants and agrees that if any action or proceeding is commenced in which Mortgagee in good faith deems it necessary to defend or uphold the validity, enforceability or priority of the lien and interest of this Mortgage or to preserve the value of the security for this Mortgage, all sums paid by Mortgagee for the expense of any such litigation to prosecute or defend the rights, lien and security interest created by this Mortgage (including reasonable attorneys' fees) shall be paid by Mortgagor, together with interest thereon at the rate then applicable under the Note and any such sums and the interest thereon shall be a lien and security interest on the Property prior to any right or title to, interest in or claim upon the Property attaching or accruing subsequent to the lien and security interest of this Mortgage, and shall be secured by this Mortgage.
- 4.10 Mortgagor covenants to furnish from time to time within fifteen (15) days after Mortgagee's request, a written statement, duly acknowledged, of the amount due upon this Mortgage, whether any alleged offsets or defenses exist against the Indebtedness and whether any defaults exist under the Loan Documents.
- 4.11 Mortgagor covenants and agrees that he will keep and maintain books and records of account, or cause book, and records of account to be kept and maintained in which full, true and correct entries shall be made of all dealings and transactions relative to the Property, which books and records of account shall, at reasonable times and on reasonable notice, be open to the inspection of Mortgagee and its accountants and other duly authorized representatives. Mortgagor shall pay all expenses of the audit and other services, which expenses shall be secured hereby as additional indebtedness and shall be immediately due and revable with interest thereon at the rate of interest as set forth in the Note and shall be secured by this Mortgage.

#### ARTICLE V TRANSFER OR MORTGAGE OF PROPERTY

5.01 Mortgagor will not, without the prior written consent of Mortgagee, further mortgage, grant a deed of trust, pledge or otherwise dispose of or further encumber, whether by operation of law or otherwise, any or all of its interest in the Property. Mortgagor will not, without the prior written consent of Mortgagee, sell, assign, or transfer the Property or any interest therein. Any sale, assignment, transfer, mortgage, deed of trust, pledge, change or other disposition or encumbrance made in violation of the above provisions shall be null and void and of no force and effect and the making thereof shall constitute an Event of Default hereunder.

#### ARTICLE VI PERFORMANCE OF MORTGAGOR'S OBLIGATIONS

6.01 Upon the occurrence of an Event of Default under this Mortgage, then, without limiting the generality of any other provision of this Mortgage, and without waiving or releasing Mortgagor from any of its obligations hereunder, Mortgagee shall have the right, but shall be under no obligation, to pay any Taxes or other

payment, or any sums due under this Mortgage, and may perform any other act or take such action as may be appropriate to cause such other term, covenant, condition or obligation to be promptly performed or observed on behalf of Mortgagor. In any such event, Mortgagee and any person designated by Mortgagee shall have, and is hereby granted, the right to enter upon the Property at any time and from time to time for the purposes of performing any such act or taking any such action, and all moneys expended by Mortgagee in connection with making such payment or performing such act (including, but not limited to, legal expenses and disbursements), together with interest thereon at the default rate set forth in the Note from the date of each such expenditure, shall be paid by Mortgagor to Mortgagee within ten (10) days after written notice to Mortgagor demanding such payment, and shall be secured by this Mortgage, and Mortgagee shall have same rights and remedies in the event of nonpayment of any such sums by Mortgagor as in the case of a default by Mortgagor in the payment of the Indebtedness. Nothing in this Section or in any other part of this Mortgage shall be construed to require Mortgagee to make any payment or perform any obligation of Mortgagor or any of them. Any action taken by Mortgagee hereunder or in relation to the Property is for the sole benefit of Mortgagee and no other person shall rely upon any action, inaction, inspection or other act of Mortgagee in dealing with the Property or Mortgagor. Mortgagor agrees to apply said rents, issues and profits, whenever received, to payment of the Indebtedness, all Taxes on or against the Property and other sums secured hereby.
- 7.02 The assignment contained in this Article VII is given as codescrat security and the execution and delivery hereof shall not in any way impair or diminish the obligations of the Mortgagor, nor shall this assignment impose any obligation on Mortgagee to perform any provision of any contract pertaining to the Property or any responsibility for the non-performance thereof by Mortgagor or any other person. The assignment under this Article VII is given as a primary pledge and assignment of the rights described herein and such assignment shall not be deemed secondary to the security interest and Mortgage of Mortgagor in the Property. Mortgagee shall have the right to exercise any rights under this Article VII before, together with, or after exercising any other rights under this Mortgage.
- 7.03 Mortgagor shall observe and perform all covenants, conditions and agreements in each lease to which it is a party, now or hereafter affecting any portion of the Property. Mortgagor shall not, without the prior written consent of Mortgagee, (a) accept any installments of rem for more than one month in advance or any security deposit for more than an amount equal to two months' rent, or (b) take any action or fail to take any action or exercise any right or option which would permit the tenant under any lease to cancel or terminate such lease, or (c) amend or modify any lease in a manner which would (i) decrease the rent payable per unit of time under the lease, (ii) decrease the payments to be made by the tenant under the lease for rent, taxes, insurance or other expenses. (iii) decrease the term of the lease, (iv) impose any additional obligations on the landlord under the lease, or (v) consent to a sublease or a substitution of tenants under the lease. Mortgagor agrees that hereafter it shall not assign any of the rents or profits of the Property.

### ARTICLE VIII DEFAULT

- 8.01 The occurrence of any one or more of the following events shall constitute an event of default (each, an "Event of Default") under this Mortgage:
  - (a) Failure of Mortgagor to observe or perform any of the covenants or conditions by Mortgagor to be performed under the terms hereof.
  - (b) Nonpayment of principal under the Note when due, or nonpayment of interest under the Note or of any other obligations under any of the Loan Documents within five days after the same becomes due.
  - (c) The occurrence of a default by Mortgagor or any guarantor of any of the Indebtedness under any other Lean Document not remedied within any applicable cure period.
  - (d) Any warranty or representation of Mortgagor made hereunder was inaccurate or misleading in any material respect when made.
  - Mortgago, or any guarantor of any of the Indebtedness shall file a voluntary petition in bankruptcy or shall be a fjulicated a bankrupt or insolvent, or shall file any petition or answer seeking any reorganization, arrangement, composition, readjustment, liquidation, dissolution, or similar relief under the present or any future applicable federal, state or other statute or law, or shall seek or consent to or acquiesce in the appointment of any crustee, receiver or liquidator of Mortgagor or any guarantor of any of the Indebtedness, or of all or any substantial part of their respective properties or of the Property; of if within sixty (60) days after the commencement of any proceeding against Mortgagor or any guarantor of any of the Indebtedness seeking any reorganization, arrangement, composition, readjustment, liquidation, dissolution, or similar relief under the present or any future federal bankruptcy act or any present or future applicable federal, state or other statute or law, acc) proceeding shall not be dismissed; or if, within thirty (30) days after the appointment of any trustee, receiver or liquidator of the Mortgagor or any guarantor of any of the Indebtedness (without the consent or acquiescence of such party) or of all or any substantial part of their respective properties or of the Property, such appointment shall not have been vacated or stayed on appeal or otherwise; or if, within sixty (60) days after the expiration of any such stay, such appointment shall not have been vacated.
- 8.02 If an Event of Detault described in Section 8.01(e) shall occur which is not cured within any applicable grace period provided for, the entire Indebtedness shall immediately become due and payable without any election or action on the part of Mortgagee. If any other Event of Defaute shall occur which is not cured within any applicable grace period provided for, Mortgagee may, at its option, exercise any and all of the following remedies:
  - (a) Declare the unpaid portion of the Indebtedness to be immediately due and payable, without turther notice or demand (each of which hereby is expressly waived by Mortgagor), whereupon the same shall become immediately due and payable.

  - (c) Appoint a receiver for the Property, or any part thereof, and of the net income, rents, issues and profits thereof, without regard to the sufficiency of the Property covered by this Mortgage or any other security, and without the showing of insolvency on the part of Mortgagor or fraud or mismanagement, and without the necessity of filing any judicial or other proceeding for appointment of a receiver.
