MORTGAGE, SECURITY AGREEMENT AND ASSIGNMENT OF LEASES AND RENTALS

THIS MORTGAGE, SECURITY AGREEMENT AND ASSIGNMENT OF LEASES AND RENTALS is made as of AUGUST 3, 1998 R & G Machinery, Inc., a(n) Illinois corporation (herein called the "Mortgagor"), to THE FIRST NATIONAL BANK OF CHICACO (the "Mortgagee"), a rational banking association.

WITNESSETH:

WHEREAS, the Mortgagor is indebted to Mortgagee in for principal sum of two hundred thousand Dollars (\$ 200,000.00 so much thereof as may be distaursed and outstanding from time to time under a promissory note dated as of the due hereof from Mortgagor payable to the order of Mortgagie in the original principal amount of \$ 200,000.00 (said note and all amendments, modifications or renewals thereof, the "Note") plus interest in the amount as provided in and evidenced by the Note, which Note is incorporated herein by this reference.

NOW THEREFORE, to secure (a) the payment of the indebtedness evidenced by the Note, together with interest thereon and any fees in connection therewith (the "Indebtedness"), (b) the repayment of any advances or expenses of any kind incurred by Mortgagee pursuant to the provisions of or on account of the Note or big Mortgage, (c) the repayment of future advances, if any, disbursed by Mortgagee to Mortgagor in accordance with the terms of the Murgage or the Note in excess of the principal amount of the Indebtedness, and (d) the re to mance and observance of all of the terms, covenants, provisions and agreements of this Mortgage, the Note and all other documents now or hereafter executed in connection with the Indebtedness (collectively, the "Loan Documents"), all of the foregoing not to exceed the amount of \$ 400,000.00 , the Mortgagor hereby agrees as follows:

ARTICLE I GRANT

1.01 The Mortgagor hereby grants, bargains, sells, releases, conveys, assigns, transfers, mortgages and confirms unto the Mortgagee, and grants a security interest in, the real estate described in Exhibit A attached hereto and made a part hereof (the "Real Estate"), which with the property, estates and interests hereinafter described is referred to herein as the "Property";

Together with, all rents, issues, profits, royalties, income and other benefits derived from the Real Estate, subject to the right, power and authority hereinafter given to Mortgagor to collect and apply such tents;

Together with, all leasehold estate, right, title and interest of Mortgagor in and to all leases or subleases covering the Real Estate or any portion thereof now or hereafter existing or entered into, and all right, title and interest of Mortgagor thereunder, including, without limitation, all cash or security deposits, edvance rentals, and deposits or payments of similar nature;

Together with, all easements, rights-of-way and rights pertaining thereto or as a means of access thereto, and all tenements, hereditaments and appurtenances thereof and thereto:

Together with, any and all buildings and improvements now or hereafter erected thereon, including, but not limited to, the fixtures, attachments, appliances, equipment, machinery, and other articles attached to said buildings and improvements; and

Together with, all the estate, interest, right, title, other claims or demands, including claims or demands with respect to the proceeds of insurance, which Mortgagor now has or may bereinafter acquire in the Real Estate. and any and all awards made for the taking of eminent domain, or by any proceeding or purchase in lieu thereof, of the whole or any part of the Real Estate, including without limitation any awards resulting from a change of grade of streets and awards for severance damages

To have and hold the Property unto the Mortgagee, and its successors and assigns forever, for the uses and purposes bereit set fort.

ARTICLE II REPRESENTATIONS

- 2.01 Mortgagor represents that it has good and marketable title to the Property. Mortgagor represents that it has good right and full power to sell and convey the same and that it has duly executed and delivered this Mortgage pursuant to proper directic as and that Mortgagor will make any further assurances of title that the Mortgagee may require and will defend the Troperty against all claims and demands whatsoever.
- 2.02 Mortgagor represents that are proceeds of the loan evidenced by the Note will be used for the purposes specified in Paragraph 6404 of Carrie, 17 of the Illinois Revised Statutes and that the principal sum evidenced by the Note constitutes a business loan which comes within the purview of such paragraph.
- 2.03 Neither Mortgagor nor, to the beat of Mortgagor's knowledge, any previous owner of the Property or any third party, has used, generated, stored or dispised of any Hazardous Substances on the Property. For the outposes of this representation and warranty. Hazardou, Substances shall include, but shall not be formed to, any toxic or hazardous westes, pollutarits or substances, including, withour limitation, asbestos, PCBs, petroleum products and by-products, substances defined or listed as hazardous prostances or toxic substances or similarly identified in or purposess to the Comprehensive Environmental Respon c, Compensation and Liability Act of 1980, as amended, 42 U.S.C. 4 9601 et seq., hazardous materials identified in or pursuant to the Hazardous Materials Transportation Act. 49 IJ.S.C. 4 1802 ct. seq., hazardous wastes identified in or persuant to The Resource Conservation and Recovery Act, 42 U.S.C. 4 6901 et seq., any chemical substance or mir nor; regulated under the Toxic Substance Control Act of 1976, as amended, 15 U.S.C. à 2601 et seu., any toxic pollution under the Clean Water Act, as amended, 33 U.S.C. & 1251 et seg., any hazzedous air pollutant under the Clear Atr Act, 42 U.S.C. & 7401 et seg., and any hazardous or soxic substance or pollutant regulated under any other applicable federal, state or local environmental health or safety laws, regulations or rules of common law. Murigagor shall indemnify and hold Mortgagee emilies from and against all liability, including all foresceable and unforces able consequential damages, directly or indirectly arising out of the use, generation, storage or disposal of 1922 dous Substances, including without limitation, the cost of any required or necessary repair, clean-up or detoxification and the preparation of any closure or other required plans, whether such action is required or necessary prior to or following transfer of title to the Property, to the full extent that such action is attributable, directly or indirectly, to the use, generation, storage or disposal of Hazardous Substances on the Property.

ARTICLE III WAIVER OF REDEMPTION

3.01 Mortgagor acknowledges that the Real Estate does not constitute agricultural real estate as said term is defined in Section 15-1201 of the lilinois Mortgage Foreclosure Law (the "Act") or residential real estate as defined in Section 15-1219 of the Act. Mortgagor hereby waives any and all rights of redemption under judgment of foreclosure of this Mortgage on behalf of Mortgagor, and on behalf of each and every person acquiring any interest in or title to the Real Estate or of any nature whatsoever subsequent to the date of this Mortgage. The foregoing waiver of right of redemption is made pursuant to the provisions of Section 15-160(B) of the Act. To the fullest extent permitted under applicable law, Mortgagor shall not, and will not, apply for or avail itself of any appraisement, valuation, stay, extension or exemption law, or so-called "Moratorium Laws," now existing or hereafter enacted, in order to prevent or hinder the enforcement or foreclosure of this Mortgage, but hereby waives the benefit of such laws. Mortgagor for itself and all who may claim through or under it waives any and all right to have the Real Estate, and any estates comprising the Real Estate, marshalled upon any foreclosure of the lien hereof and agrees that any court having jurisdiction to foreclose such lien may order the Real Estate sold as an entirety.

ARTICLE IV MORTGAGOR'S COVENANTS

- 4.01 Mortgago: covenants and agrees to pay the Indebtedness and the other sums secured hereby in the manner and at the times provided for in the Loan Documents.
- 4.02 Mortgagor cove is and agrees to pay, or cause to be paid, when due and payable by Mortgagor:
 - (a) all real estate taxes, personal property taxes, assessments, license fees, water and sewer rates and charges, and all other governmental levies and charges, of every kind and nature whatsoever, general and special, ordinary and extraordinary, unforeseen as well as foreseen, which shall be assessed, levied, confirmed, imposed or be way a lien upon or against the Property or any portion thereof, and all taxes, assessments and charges upon the rents, issues, income or profits of the Property, or which shall become payable with respect thereto or with respect to the occupancy, use or possession of the Property, whether such taxes, assessments or charges are levied directly or indirectly (hereinafter collectively called the "Impositions"); and
 - (b) all other payments or charges require to be paid to comply with the terms and provisions of this Mortgage.

Within ten (10) days after written demand therefor, Moregagor shall deliver to Mortgagee the original, or a photostatic copy, of the official receipt evidencing payment of Impositions or other proof of payment satisfactory to Mortgagee. Failure of Mortgagor to deliver to Mortgagee said receipts or to submit other proof satisfactory to Mortgagee as aforesaid shall constitute an Event of Default herevader.

4.03 Mortgagor covenants and agrees to keep and maintain, or cause to be kept and maintained, the Property (including all improvements thereon and the sidewalks, sewers, and curbs) in good order and condition and will make or cause to be made, as and when the same shall become necessary, all structural and nonstructural. ordinary and extraordinary, foreseen and unforeseen repairs and all muntenance necessary to that end. Furthermore, and without limiting the generality of the foregoing, Mortgager will suffer no waste. All repairs and maintenance required of Mortgagor shall be (in the reasonable opinion of Mortgagor,) of first-class quality. SOM CO

- 4.04 Mortgagor covenants and agrees that this Mortgage is and will be maintained as a valid mortgage lien on the Property and that Mortgagor will not, directly or indirectly, create or suffer or permit to be created, or to stand against the Property, or any portion thereof, or against the rents, issues and profits therefrom, any lien (including any liens arising with respect to the payment of Impositions), security interest, encumbrance or charge whether prior to or subordinate to the lien of this Mortgage unless written approval is first obtained from Mortgagee. Mortgager will keep and maintain the Property free from all liens of persons supplying labor and materials for the construction, modification, repair or maintenance of any building or site improvement whether or not on the Property.
- 4.05 Mortgagor covenants and agrees, so long as the Indebtedness remains outstanding, to comply with ail regulations, rules, ordinances, statutes, orders and decrees of any governmental authority or court applicable to the Mortgagor or applicable to the Property or any part thereof and will promptly cure any violation of law and comply with any order of any such governmental authority or court, including, without limitation, in respect of the repair, replacement or condition of the Property and any governmental regulations concerning environmental control and improvements.
- 4.06 Mortgagor covenants and agrees that all awards heretofore or hereafter made by any public or quasi-public authority to the present and all subsequent owners of the Property by virtue of an exercise of the right of emineral domain by such authority, including any award for a taking of title, possession or right of access to a public way. or for any change of grade of streets affecting the Property, are hereby assigned to the Mortgager.
- 4.07 Mortgagor covenants and agrees that neither the value of the Property nor the lien of this Mortgage will be materially directioned or impaired in any way by any act or omission of the Mortgagor, and the Mortgagor agrees it will not do or permit to be done to, in, upon or about said Property, or any part thereof, anything that may in any way impair the /alie thereof, or weaken, diminish, or impair the security of this Mortgage.
- 4.08 Mortgagor covenies and agrees that if any action or proceeding is commenced in which Mortgagee in good faith deems it neversary to divind or uphold the validity, enforceability or priority of the lien and interest of this Mortgage or to preserve the value of the security for this Mortgage, all sums past by Mortgagee for the expense of any such litigation to prosecute or defend the rights, lien and security interest created by this Mortgage (including reaconable attorneys' (ees) shall be paid by Mortgagor, together with interest thereon at the rate then applicable under the Note, and any such sums and the interest thereon shall be a lien and security interest on the Property prior to any right or title to, ir ren'st in or claim upon the Property attaching or accruing subsequent to the lien and security interest of this Mor gage, and shall be secured by this Mortgage.

ARTICLE V TRANSFER OR MORTGAGE OF PROPERTY

5.01 Mortgagor will not, without the prior written consent of Mortgages, further mortgage, grant a deed of trust, pledge or otherwise dispose of or further encumber. We other by operation of law or otherwise, any or all of its interest in the Property. Mortgagor will not, without the prior written consent of Mortgagee, sell, assign, or transfer the Property or any interest therein. Any sale, assignment, transfer, mortgage, deed of trust, pledge. change or other disposition or encumbrance made in violation of the above provisions shall be null and void and of no force and effect and the making thereof shall constitute an Event of Default hereunder. ARTICLE VI PERFORMANCE OF MORTGAGOR'S OBLIGATIONS

6.01 Upon the occurrence of an Event of Default under this Mortgage, then, without limiting the generality of any other provision of this Mortgage, and without waiving or releasing Mortgagor from any of its obligations hereunder. Mortgagee shall have the right, but shall be under no obligation, to pay any Impositions or other payment, or any sums due under this Mortgage, and may perform any other act or take such action as may be appropriate to cause such other term, covenant, condition or obligation to be promptly performed or observed on behalf of Mongagor. In any such event, Mongagee and any person designated by Mongagee shall have, and is hereby granted, the right to enter upon the Property at any time and from time to time for the purposes of performing any such act or taking any such action, and all moneys expended by Mortgagee in connection with making such payment or performing such act (including, but not limited to, legal expenses and disbursements). together with interest thereon at the default rate set forth in the Note from the date of each such expenditure, shall be paid by Mortgagor to Mortgagee within ten (10) days after written notice to Mortgagor demanding such payment, and shall be secured by this Mortgage, and Mortgagee shall have the same rights and remedies in the event of nonpaymer, of any such sums by Mortgagor as in the case of a default by Mortgagor in the payment of the Indebtedness. Nothing in this Section or in any other part of this Mortgage shall be construed to require Mortgagee to make any payment or perform any obligation of Mortgagor. Any action taken by Mortgagee hereunder or in relation to the property is for the sole benefit of Mortgagee and no other person shall rely upon any action, inspection of other act of Mortgagee in dealing with the Property or Mortgagor. Upon the occurence of an Event of Default under this Mortgage, (a) in making any payment hereby authorized telating to taxes and assessments. Mortgagee may do so according to any bill, statement or estimate procured from the appropriate public office without inquiry to the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax it in or title or claim thereof, or (b) in making any payment hereby authorized for the purchase, discharge, compromise or settlement of any other lien, Mortgagee may do so without inquiry as to the validity or amount of any claim for liea which may be asserted.

ARTICLE VII ASSIGNMENT OF LEASES, RENTS AND CONTRACTS

7.01 Mortgagor hereby assigns to Mortgagee all of Mortgagor's interest it all rents, issues and profits of the Property, as further security for the payment of the Indebtedness and order sums secured hereby. Mortgagor grants to Mortgagee the right to enter the Property and to let the Property, or any part thereof, and to apply said rents, issues, profits and proceeds after payment of all charges and expenses, on account of the Indebtedness and other sums secured hereby. This assignment and grant shall continue in effect until the Indebtedness and other sums secured hereby are paid in full. Mortgagee hereby agrees not to exercise the right to order the Property for the purpose of collecting said rents, issues or profits, and Mortgagor shall be entitled to collect and receive said rents, issues, profits and proceeds, until the occurrence of an Event of Default hereunder; provided, that any rents, issues and profits collected and received by Mortgagor after the occurrence of an Event of Default hereunder shall be deemed collected and received by Mortgagor in trust for Mortgagee and Mortgagor shall account to Mortgagee for the full amount of such receipts. Mortgagor agrees to apply said rents, issues and profits, whenever received, to payment of the Indebtedness, all Impositions on or against the Property and other sums secured hereby.

7.02 The assignment contained in this Article VII is given as collateral security and the execution and delivery hereof shall not in any way impair or diminish the obligations of the Mortgagor, nor shall this assignment impose any obligation on Mortgagee to perform any provision of any contract pertaining to the Property or any responsibility for the non-performance thereof by Mortgagor or any other person. The assignment under this Article VII is given as a primary pledge and assignment of the rights described herein and such assignment shall not be deemed secondary to the security interest and Mortgage of Mortgagee in the Property. Mortgagee shall have the right to exercise any rights under this Article VII before, together with, or after exercising any other rights under this Mortgage.

7.03 Mortgagor shall observe and perform all covenants, conditions and agreements in each lease to which it is a party and that now or hereafter affects any portion of the Property. Mortgagor shall not, without the prior written consent of Mortgagee, (a) accept any installments of rent for more than one mainth in advance or any security deposit for more than an amount equal to two months' rent, or (b) take any action or full to take any action or exercise any right or option which would permit the tenant under any lesse to cancel or terminate such lease, or (c) amend or modify any lease in a manner which would (i) decrease the rent payable per unit of time under the lease, (ii) decrease the payments to be made by the tenant under the lease for rent, taxes, insurance or other expenses, (iii) decrease the term of the lease, (iv) impose any additional obligations on the landlord under the lease, or (v) consent to a sublease or a substitution of tenants under the lease. Mortgagor agrees that hereafter it shall not assign my of the rents or profits of the Property.

7.04. Nothing herein contained shall be construed as constituting Mortgagee a mortgagee in possession in the absence of the taking of actual possession of the Property by Mortgagee pursuant to Article IX hereof. In the exercise of the powers herein granted Mortgagee, no liability shall be asserted or enforced against Mortgagee, all such liability being expressly waived and released by Mortgagor.

ARTICLE VIII DEFAULT

- \$.01. The social mence of any one or more of the following events shall constitute an event of default (each, an "Even of Defarir") under this Mortgage:
 - (a) Failure of Aortgagor to observe or perform any of the covenants or conditions by Mongagor to be performed user the terms hereof, which is not remedied within any applicable cure period.
 - (b) Nonpayment of kincipal under the Note when due, or nonpayment of interest under the Note or of any other obligations under any of the Loan Documents within five days after the same becomes due.
 - (c) The occurrence of a refruit under any Luan Document, which is not remedied within any applicable cure period.
 - (d) Any warranty or representation of Mortgagor made hereunder was inaccurate or misleading in any material respect when made.
- 8.02 If an Event of Default shall occur which is not cured within any applicable grace period provided for. Mortgagee may, at its option, exercise any and all of the following remedies under this Mortgage:
 - (a) Declare the unpaid portion of the Indebte bess to be immediately due and psyable according to the terms of the Note.
 - (b) Enter upon the Property and take possession their of of all books, records and accounts relating
 - (c) Appoint a receiver for the Property, or any part thereo, and of the net income, rents, issues and profits thereof, without regard to the sufficiency of the Property lowered by this Mortgage or any other security, and without the showing of insolvency on the part of Mortgage or fraud or mismanagement, and without the necessity of filing any judicial or other proceeding for provintment of a receiver. 750

- (d) Hold, lease operate or otherwise use or permit the use of the Property, or any portion thereof, in such manner, for such time and upon such terms as Mortgagee may deem to be in its best interest (making such repairs, alterations, additions and improvements thereto, from time to time, as Mortgagee shall deem necessary or desirable) and collect and retain all earnings, rentals, profits or other amounts payable in connection therewith.
- (e) Sell the Property, in whole or in part:
 - (i) under the judgment or decree of a court of competent jurisdiction, or
 - (ii) sell any of the Collateral (as defined in Article XIII), in whole or on part, at public auction (if permitted by law) in such manner, at such time and upon such terms as Mortgagee may determine, or at one or more public or private sales, in such manner, at such time or times, and upon such terms as Mortgagee may determine or as provided by law.
- (f) Foreclose this Mortgage.
- (g) Exercise any other remedy now or hereafter existing in equity, at law, by virtue of statute or otherwise.
- 8.03 In case Mortgagee shall have preceded to enforce any right under the Note or this Mortgage and such proceedings shall have been discontinued or abandoned for any reason, then in every such case Mortgagor and Mortgagee shall be restored to their former resitions and the right, remedies and powers of Mortgagee shall continue as if no such proceedings had been taken.
- 8.04 In the event Mortgagee (a) grants an extension of tink on any payments of the Indebtedness, (b) takes other or additional security for the payment thereof, or (c) waives or fails to exercise any right granted herein, said act or omission shall not release Mortgagor, subsequent purchaters of the Property covered by this Mortgage or any part thereof, or any guarantee of the Note.

ARTICLE IX FORECLOSURE

9.01 In any suit to foreclose the lien hereof, there shall be allowed and included as additional indebtedness in the decree of sale all expenditures and expenses which may be paid or incurred by or on behalf of Mortgagee, or holders of the Note, for reasonable attorneys' fees, court costs, appraisers' fees, outlay; for documentary and expert evidence, stenographers' charges, publication costs and costs of procuring title insultant policies (which fees, charges and costs may be estimated as to items to be expended after entry of the decree), and all other expenses as Morigagee or holders of the Note may deem reasonably necessary to prosecute such suit or to evidence to bidders at any sale which may be had pursuant to such decree the true condition of the title to or the value of the Property. All expenditures and expenses of such nature in this Article mentioned shall become so much additional Indebtedness secured hereby and shall be immediately due and payable with interest thereon at the rate in effect under the Note when paid or incurred by Mortgagee or holders of the Note, in addition to foreclosure proceedings, the above provisions of this paragraph shall apply to (a) any proceeding to which Mortgagee or the holders of the Note shall be a party, either as plaintiff, claimant or defendant, by reason of this Mortgage or any Indebtedness hereby secured; (b) preparations for the commencement of any suit for foreclosure hereof after accrual of such right to foreclosure whether or not actually commenced; or (c) preparation for the defense of or investigation of any threatened suit, claim or proceeding which might affect the Property or the security hereof, whether or not actually commenced.

9.02 Upon or at any time after the filing of a bill to foreclose this Mortgage, the court in which such bill is filed may appoint a receiver of the Property. Such appointment may be made either before or after sale, without notice,

without regard to the solvency or insolvency at the time of application for such receiver of the person or persons, if any, liable for the payment of the Indebtedness and other sums secured hereby and without regard to the then value of the Property and the Mortgagee hereunder may be placed in possession of the Property. The receiver shall have power to collect the rents, issues and profits of the Property during the pendency of such foreclosure suit, as well as during any further times when Mortgagee, its successors or assigns, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits, and other powers which may be ascessary or are usual in such cases for the protection, possession, control, management and operation of the Property furing the whole of said period. The court from time to time may authorize the receiver to apply the net income in his hands in payment in whole or in part of the Indebtedness and other sums secured hereby, or in payment of any tax, special assessment or other lien which may be or become superior to the lien hereof or superior to a decree foreclosing this Mortgage, provided such application is made prior to foreclosure sale.

- 9.03 The proceeds of any sale of all or any portion of the Property and the earnings of any holding, leasing, operating or other use of the Property shall be applied by Mortgagee in the following order:
 - (a) first, to the sayment to Mortgagee of the costs and expenses of taking possession of the Property and of holding, using, having, repairing, improving and selling the same;
 - (b) second, to the payment of Mortgagee's attorneys' fees and other legal expenses;
 - (c) third, to the payment of accreted and unpaid interest on the Note;
 - (d) fourth, to the payment of the balance of the Indebtedness; and
 - (c) any supplies shall be paid to the parties entitled to receive it.

ARTICLE X INSPECTION

10.01 Mortgager covenants and agrees that Mortgagee, or its agents or representatives, may make such impections of the Property as Mortgagee may deem necessary or desirable, at all reasonable times and that any mack inspections shall be solely for the benefit of Mortgagee and shall not be relied upon by Mortgager for any purpose.

ARTICLE XI ASSIGNMENT BY MORTGAGEE

11.01 Mortgager may assign all or any portion of its interest hereunder and its rights granted provide and in the Note to any person, trust, financial institution or corporation as Mortgager may determine and upon such assignment, such assignment, such assignment, such assignment shall thereupon succeed to all the rights, interests, and options of Mortgager herein and in the Note contained and Mortgager shall thereupon have no further obligations or liabilities bereunder.

ARTICLE XII INSURANCE

buildings, structures and improvements now existing or hereafter created on said Property against loss or damage by fire, lightning, windstorm, hail, explosion, riot, civil commotion, aircraft, vehicles, smoke, and such other hazards, casualties, and comingencies as Mortgagee may designate. All policies of insurance required hereunder shall be in such form, companies, and amounts as may be acceptable to Mortgagee, and shall contain a mortgagee clause exceptable to Mortgagee, with loss payable to Mortgagee. Mortgager will promptly pay when due, any premiums on any policy or policies of insurance required hereunder, and will deliver to Mortgagee renewals of such policy or policies at least ten (10) days prior to the expiration dates thereof; the said policies and renewals to be marked "paid" by the issuing company or agent. Upon Mortgagor's failure to comply with the requirements of this paragraph. Mortgagee may, in its discretion, effect any insurance required hereunder and pay the premiums due therefor, and any amounts so paid by Mortgagee shall become immediately due and payable by Mortgagor with interest as described in Section 6.01 hereof, and shall be secured by this Mortgage.
