1. Defendant(s) ORLANDO RUIZ his/her/their agents, heirs, successors or assigns, be and are permanently enjoined and restrained from RENTING, LEASING, USING OR OCCUPYING THE BASEMENT AND ATTIC OF THE SUBJECT PREMISES AS DWELLING UNITS.
THERE IS A FINDING OF FULL COMPLIANCE THE BASEMENT AND ATTIC HAVING BEEN DECONVERTED TO SINGLE FAMILY RESIDENCE UNDER PERMIT # 98-066008 AND # 98-546009 ISSUED 2/25/98.

2. The court reserves jurisdiction of this matter for the purposes of modification, enforcement or termination of this permanent injunction.

3. This order is final and appealable, the court finding no just cause or reason to delay its enforcement or appeal.
