THIS ADJUSTABLE RATE RIDER is made this 7TH day of AUGUST , 1998 . and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Security Deed (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure Borrower's Adjustable Rate Note (the "Note") to BOMAC CAPITAL MORTGAGE, INC.

(the "Lender") of the same date and covering the property described in the Security Instrument and located at:
