MEMOPANDUM OF AGREEMENT

THIS MEMORANDUM OF AGREEMENT evidences that a First Amendment to Site Agreement dated July 28, 1995 was made and entered into by written agreement effective this 15th day of June, 1998, between Cole Taylor Bank as Successor Trustee under a Trust Agreement dated April 13, 1945 and known as Trust Number 5833 ("Owner"), whose address is as set forth below, James R. Neuman, as sole beneficiary of Trust Number 5833 ("Beneficiary") and PrimeCo Personal Communications, L.P. ("PrimeCo"), whose address is One Pierce Place, Itasca, IL 60143, the terms and conditions of which are incorporated herein by reference.


