MODIFICATION AGREEMENT

THAT PART OF LOT 7 IN BLOCK 11 IN "EDGEWATER" A SUBDIVISION OF PARTS OF LOTS 2, 3 AND 4 OF BILLY CALOWELL'S RESERVE, IN TOWNSHIP 40 AND 41 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN, AS PER PLAT THEREOF, RECORDED FEBRUARY 16, 1895, AS DOCUMENT NUMBER 2174831, DESCRIBED AS FOLLOWS:

Except where the context otherwise may require, it is agreed that the terms "Lender", "Mortgagee", and "Bank" when used and appearing in the Note, the Mortgage as amended and modified and by this Modification Agreement shall be construed as and mean The First National Bank of Chicago.

It is further agreed as between the Mortgagor and Mortgagee that neither the repayment of the indebtedness evidenced by the Revolving Business Credit Note, nor the obligations of the Mortgage or other security given to secure same, shall in any way be prejudiced by this Agreement, said Nortgage being intended to be modified only to the extent therein and herein mentioned and said Mortgage to continue and remain in full force and effect. The parties hereto hereby ratify, adopt and confirm their respective covenants, agreements and conditions as we forth in the Mortgage as modified by this Agreement.
