Mortgagor expressly represents, covenients to Mortgagee the following: (a) no hazardous substances, hazardous wastes, industrial waste, pollution control waste or toxic substances, within the meaning of any applicable Federal or state statute or regulation or any local ordinance (collectively, "Hazardous Substances") presently are or have been stored or other wise located on, about or adjoining the Mortgaged Premises (conectively, "Hazardous Substances") presently are or nave been stored or other wise located on, about or adjoining the Mortgaged Premises and that, within the definition of such statutes, ordinances or regulations, no part of the Mortgaged Premises or the adjoining property, including the ground-water located thereon, is presently contaminated by any Hazardous Substances; (b) until the Note and all other indebtedness secured by this Mortgage are paid in full, all Hazardous Substances, which may be used by any person for any purposes upon the Mortgaged Premises or adjoining property, shall be used or stored thereon only in a safe, approved manner, in accordance with all industrial standards and all statutes, ordinances, regulations and requirements of any governmental authority; (c) the Mortgaged Premises and the adjoining property will not be used for the principal purpose of storing Hazardous Substances and that no such storage or use will otherwise be allowed on the Nortgaged premises which will statute or increase the likelihood of agustics the release of Hazardous Substances and Hazardous Substances and Hazardous Substances and the Azardous December 100 of the Azardous December 10 premises which will cause or increase the likelihood of causing the release of Hazardous Substances onto the Mortgaged Premises; and (d) Mortgagor shall immediately notify the Mortgagee as soon as Mortgagor knows or suspects that a Hazardous Substance has been released on the Mortgaged Premises or of any violation of any Federal, state or local ordinance, statute, rule or regulation dealing with the presence of any Hazardous Substance or environmentally dangerous conditions affecting the Mortgaged Premises.

Mortgagor hereby indemnifies and saves Mortgagee harmless of and from any claim, loss, liability and damage including ressonable attorneys fees incurred by Mortgagar to reason of any actual or alleged violation of any applicable statute, ordinance, rule or regulation for the protection of the environment which for urs upon the Mortgaged Premises or any adjoining parcels or by reason of imposition of any governmental fien for the recovery of environmental cleanup costs expended by reason of such violation (collectively "Environmental Costs"); provided that, to the extent that Mortgagee is strictly liable under any such statute or ordinance, Mortgagor's obligation to Mortgagee under this indemnity shall likewise be without regard to fault on the part of Mortgagor with respect to the violation of law which results in liability to the Mortgages. Mortgagor further agrees that this indemnity shall nontinue to remain in full force and effect beyond the term of the indebtedness or obligation which is secured by this Mortgage and shall be termine to only when there is no further obligation of any kind whether in law or in equity or otherwise of Mortgages in connection with any such environmental cleanup costs, environmental flens or environmental matters involving the Mortgaged Premises.

Mortgagor promises to pay to Mortgagee or demand all Environmental Costs incurred by Mortgagee. This Mortgage shall secure, in addition to the Note and all other indebtedness any obligations secured hereby, the payment of all Environmental Costs incurred by Mortgagee.

15. Any one or more of the following shall considered an event of default ("Event of Default") hereunder: (a) default in the payment, when due (whether by lapse of time, acceleration or otherwise) of the principal of or interest on the Note or of any other indebtedness hereby secured; (b) default for more than 30 days in observance or corruptiance with any other covenant, warranty, term or provision of this Mortgage or of any separate assignment of leases and/or rents securing the Note or of any other instrument or document securing the Note or relating thereto; (c) any representation or warranty made by Mortgagor her in or in any separate assignment of leases and/or rents securing the Note or in any other instrument or document securing the Note or relating increto or in any statement or certificate furnished by it pursuant hereto or thereto proves to be untrue or misleading in any material respect as (if the date of issuance or making thereof; (d) the Mortgaged Premises or any part thereof shall be assigned, sold, transferred or conveyed, whether columnarily or involuntarily, by operation of law or otherwise, except for sales of obsolets, worn out or unusable fixtures or personal property which are concurrently replaced with similar fixtures or personal property at least equal in quality and condition to those sold and owned by Mortgage free of any lien, charge or encumbrance other than the lien hereof; (e) equal in quality and condition to those sold and owned by Morgage (* fre.) of any fien, charge or encumbrance other than the fien fereof; (e) any indebtedness secured by a lien or charge on the Mortgaged Premise or any part thereof is not paid when due or proceedings are commenced to foreclose or otherwise realize upon any such lien or charge or tay) a receiver appointed for the property subject thereto or to place the holder of such indebtedness or its representative in possession thereoi, (f) Mortgagor or Guarantor becomes insolvent or bankrupt or admits in writing its, his or her inability to pay its, his or her debts as they mature or makes an assignment for the benefit of creditors or applies for or consents to the appointment of a trustee, custodian or receiver for the major part of its, his or her property or such a trustee, custodian or receiver is appointed for Mortgagor, Guarantor or for the major part of the properties of any of them and is not discharged within 30 days after such appointment, or bankruptcy, reorganization, arrangement, insolvency, readjustriest, liquidation, dissolution or other proceedings for relief under any present or future bankruptcy laws or laws or their statute, law or regulation for the not debtors are instituted against such party are consented to prisonal for the not dismissed within 30 days after such institugagor or Guarantor and if instituted against such party are consented to or acquiesced ir or a e not dismissed within 30 days after such institu-tion, or Mortgagor or Guarantor takes any action in contemplation of or furtherance of any of the foregoing; (g) there shall be any execution. attachment or lavy on the Mortgaged Premises not stayed or released within 30 days; (h) any continuous or condition exists which is specified as an event of default in any separate assignment of leases and/or rents securing the Note with any other instrument or document securing the Note or relating thereto; (i) any financial or other information submitted by Mortgagor or Gurar.or to Mortgagoe proves untrue in any material respect; (j) the Mortgagod Premises are abandoned; (k) Mortgagor or Guarantor shall fall or refuse to pay drivironmental Costs as herein defined. or (i) any hazardous substances or wastes, industrial wastes, poliution control wastes or toxic substances, within the meaning of any applicable Federal, state or local environmental statute, ordinance, rule or regulation (collectively "Hazardous Substances") shall be installed, used, generated, manufactured, produced, stored, released discharged or disposed of on, under or about the Mortgaged premises, or transported to or from the Mortgaged Premises, in violation of any Federal, state or local environmental statute, ordinance, rule or regulation (or regulation (collectively "Hazardous Substances") shall be installed, used, generated, manufactured, produced, stored, released or olical environmental statute, ordinance, rule or regulation; or (m) Mortgaged Oremises shall fail or refuse voluntarily to clean up and to bear the cost of cleaning up all Hazardous Substances on, under or according to a literature within 50 days after their discovery, or after receipt from any applicables. within 60 days after their discovery, or after receipt from any environmental agency or any other governmental unit or authority that a violation of any applicable Federal, state or local environment statute, ordinance, rule or regulation has occurred; When any Event of Default has occurred and is continuing (regardless of the pendency of any proceeding which has or might have the effect of preventing Mortgagor from complying with the terms of this instrument and of the adequacy of the security for the Note) and in addition to such other rights as may be available under applicable law, but subject at all times to any mandatory legal requirements: (a) Mortgages may, by written notice to Mortgagor, declare the Note and all unpaid indebtedness of Mortgagor hereby secured, including any interest then accrued thereon, to be forthwith due and payable, whereupon the same shall become and be forthwith due and payable, without other notice or demand of any kind; (b) Mortgages shall, with respect to any part of the Mortgaged Premises constituting property of the type in respect of which realiza-tion on a lien or security interest granted therein is governed by the Illinois Uniform Commercial Code, have all the rights, options and remedies of a secured party under the illinois Uniform Commercial Code; (c) Mortgages may proceed to protect and enforce the rights of Mortgages hereunder (i) by any action at law, sult in equity or other appropriate proceedings, whether for the specific performance of any agreement contained here. (i) by any action at law, sult in equity or other appropriate proceedings, whether for the specific performance of any agreement contained help or for an injunction against the violation of any of the terms hereof, or in aid of the exercise of any power granted hereby or by taw; or (i)Do the foreclosure of this Montgage in any manner permitted by law; (d) Montgagee shall, as a matter of tight, without notice and without giving bond to Montgagor or anyone claiming by, under or through it, and without regard to the solvency or insolvency of Montgagor or the then viting of the Montgagod Premises, be entitled to have a receiver appointed of all or any part of the Montgagod Premises and rents, issues and premises. thereof, with such power as the court making such appointment shall confer, and Mortgagor hereby consents to the appointment of such received and shall not oppose any such appointment.
