AMENDMENT TO RIVER FOREST STATE BANK AND TRUST COMPANY MEMPHIS CORP BANK HOME EQUITY LINE OF CREDIT AGREEMENT AND THE MORTGAGE STATEMENT AND HOME EQUITY LINE OF CREDIT MORTGAGE

THIS AMENDMENT, made this 17th day of August, 1998, by and between Carl A. Brown III and Christine L. Bush, as Borrowers, under the hereinafter described Credit Agreement and as Mortgages under the hereinafter described Mortgage hereinafter referred to as the "Borrower", and RIVER FOREST STATE BANK AND TRUST COMPANY hereinafter referred to as the "Bank".

W I T N E S S E T H:

WHEREAS, the Borrower has executed that certain Home Equity Line of Credit Agreement and Mortgage Statement dated August 16, 1995 (the "Credit Agreement") pursuant to which the Bank established a Home Equity Line of Credit thereon for the benefit of the Borrower in the maximum amount of \$17,000.00 bearing interest at an **ANNUAL PERCENTAGE RATE** equal to 2.75% in excess of the Prime Rate identified therein for a period with an initial draw period identified therein of 7 years from the date of the Credit Agreement; and

WHEREAS, in order to secure to the Bank the repayment of the indebtedness incurred pursuant to the Credit Agreement, the Borrower executed and delivered to the Bank that certain Home Equity Line of Credit Mortgage dated the same date (the "Mortgage") and recorded on August 18, 1995, in Cook County, Illinois, as document number 0049081, pursuant to which the Borrower mortgaged, granted and conveyed to the Bank certain real property described therein and an Exhibit A attached hereto; and

WHEREAS, the Borrower has requested that the Bank change certain terms of the Home Equity Line contained in the Credit Agreement and/or the Mortgage; and

WHEREAS, the Bank and the Borrower have agreed to change such terms of the Home Equity Line and desire to amend the Credit Agreement and the Mortgage to reflect such changes.

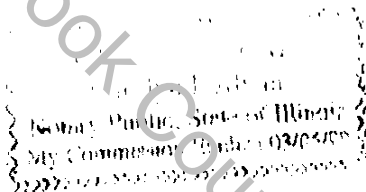
