AN ORDINANCE DISCONTINUING THE VILLAGE OF RIVER FOREST SPECIAL SERVICE AREA NUMBER 2

WHEREAS, on August 12, 1991 the Village of River Forest did establish Special Service Area Number 2 for the purpose of repaving of alleys and related expenses by adopting Ordinance Number 2446 and;

WHEREAS, the cost of constructing said improvement was to be shared equally between the Village and the property owners concerned, and;

WHEREAS, the necessary funds from each property owner have been collected and the required Village contribution has been made, and;

WHEREAS, said improvement in Special Service Area Number 2 has been completed and paid in full.

NOW, THEREFORE, Be It Ordained by the President and Board of Trustees of the Village of River Forest, Cook County, Illinois as follows:

Section 1: This Board finds that the improvement pertaining to Special Service Area Number 2 has been completed, and all costs and expenses pertaining thereto, have been paid in full and there are no other costs or expenses due or owing with respect thereto.

Section 2: That Special Service Area Number 2 is hereby discontinued. A certified copy of this ordinance shall be presented to the Cook County Recorder of Deeds office and the Cook County Clerks office.

Section 3: That this Ordinance shall be in full force and effect from and after its passage approval and publication as provided by law. The Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

Lots 1 through 28 in Block 2, including the alley therein, in Henry Field's Subdivision of the East 1/2 of the Southwest 1/4 of Section 12, Township 39 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois.

A map of said territory being attached hereto as EXH (B) 3.

Section 4: PURPOSE OF LAND. Village of River Forest

Special Service Area Number 2 is established to provide special municipal services to said area in addition to services provided to the Village generally. Included in said purposes shall be the repaving of alleys within the area and related expenses, including related expenses (including attorney and engineering fees and expenses and administrative costs), Village of River Forest special Service Area Number 2 is also created so that taxes will be levied on property in the special Service Area in addition to all other Village taxes so levied, provided such taxes shall not exceed one-half (50%) of the cost of the project (including such related expenses) and shall not exceed \$5,000.00.

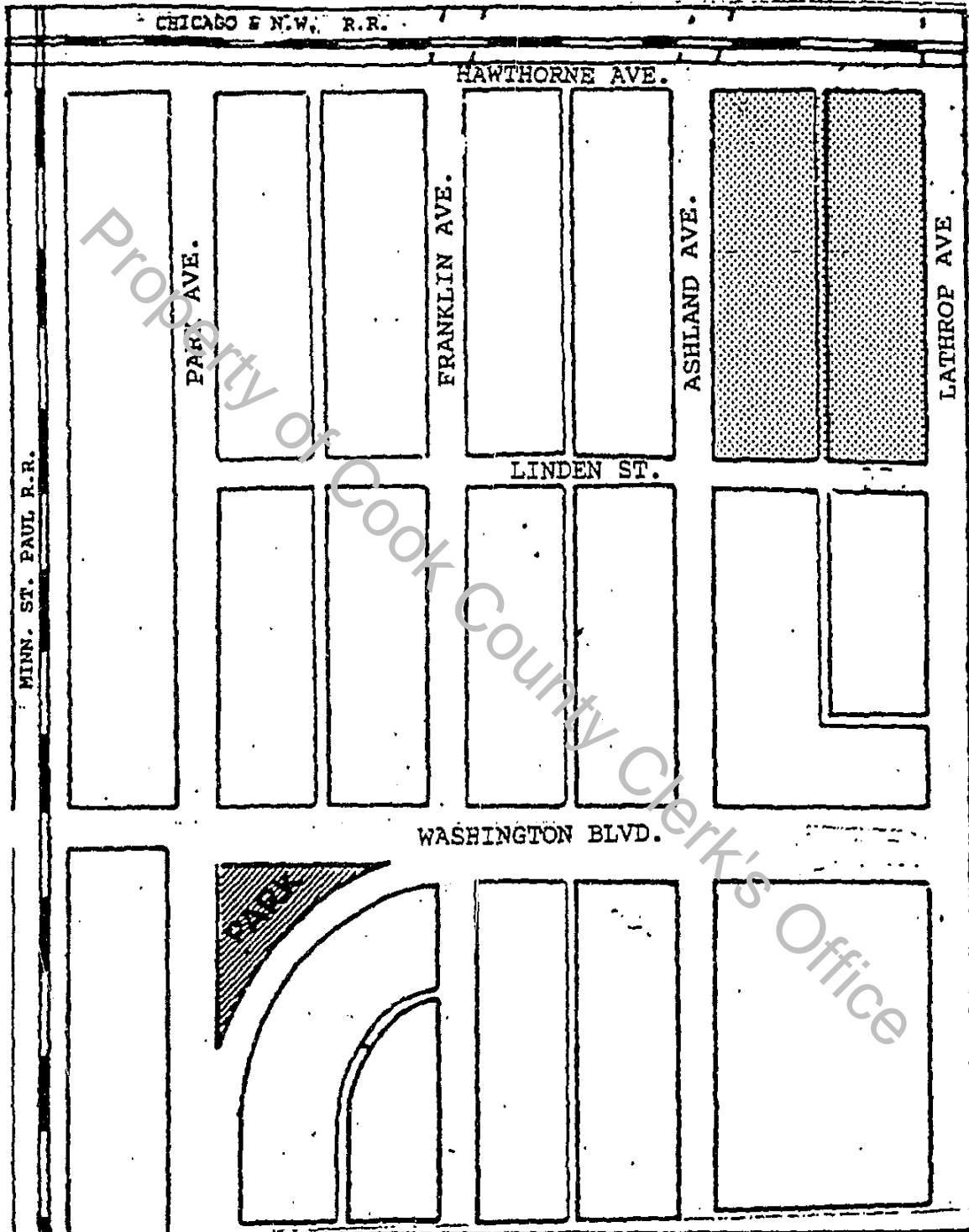

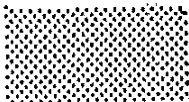
