MODIFICATION A TREEMENT


This AGREEMENT entered into this 13th day of AUGUST. 1998 by and between THE FIRST NATIONAL BANK OF LINCOLNWOOD, hereinafter called "BANK", and COLE TAYLOR BANK, as Trustee, under Trust No. 960675, dated MAY, J., 1996 hereinafter called "MORTGAGOR".

WITNESSETIE

(1) BANK is the holder of a certain Promissory Note dated MAY 31, 1996 in the original face amount of ONE HUNDRED FIFTY SIX THOUSAND SEYEN HUNDRED FIGHTY ONE AND 31/100 mona DOLLARS (\$156,781.31) executed by MORTGAGOR and accured by a Mortgage to The First National Bank of Lincolnwood, and recorded on JUNE 19. 1996 in the office of RECORDER OF DEEDS in the County of COOK, State of Illinois as Document No. 96482261 and by an Assignment of Rents to Bank recorded on JUNE 19, 1996 in the office of RECORDER, OF DEEDS, in the County of COOK State of Illinois, as Document No. 96482262 on Real listate legally described as follows:

LOT 270 IN KRENN AND DATO'S DEVON-REDZIE ADDITION TO NORTH EDGEWATER, BEING A SUBDIVISION OF THE NORTHWEST 1/4 OF THE NORTHWEST 1/4 OF SECTION 1, TOWNSHIP 40 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, HALINOIS.

- (2) MORTGAGOR has reduced its obligation to \$148.802.77 and MORTGAGOR has requested BANK to modify the terms of payment under said Note and Mortgage, and
 - (1) BANK has agreed to modify the terms of the Note and Mortgage, and

- (4) COLB TAYLOR BANK, as Trustee, under the Mortgage described above has consented to this modification.
- (5) Said Principal Balance together with interest is hereby modified to be payable as follows:

The principal sum and interest to be payable at the rate of 7.000% per annum in instalments as follows: \$1.060.95 or more on the lat day of September, 1998 and \$1.060.95 or more on the lat day of each and every month thereafter until said note is fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due on the lat day of August, 2003. All such payments received on this note shall be applied first to the payment of interest accrued to the date the instalment is paid, and any amount remaining from an instalment after application to interest shall be applied in reduction of unpaid principal. If the monthly instalment payment is insufficient to pay the interest accrued for any month, the Borrower agrees to pay the actual billing from the bank of interest accrued for that month. Interest on this note shall increase to a rate per annum of 9.00% upon an Event of Default, or after the due date of the final instalment until the lighthings are paid. Interest on this note will be computed based upon a 360-day year for the actual number of days elapsed. All of said principal and interest being made payable at the office of The First National Bank of Lincolnwood, 6401 N. Lincoln Avenue, Lincolnwood, filinois 60645.

(6) This AGREEMENT is supplementary to said Mortgage and Assignment of Rents and said Mortgage and Assignment of Rents shall continue as a good and valid lien on the Real Estate. Neither the Promissory Note, the Mortgage, nor the Assignment of Rents shall in any way be prejudiced by this ASSEEMENT.

All of the provisions of the Promissory Note, Mortgage, and Assignment of Rents shall remain in full force and effect and he binding on the parties hereto except as herein expressly modified.
