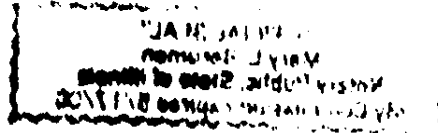


WARRANTY DEED

Lot 5 in Wolf Creek Subdivision, being that part of Lot 8 (excepting therefrom the West 5 Acres thereof) lying westerly of the following described line: Commencing on a point in the Northwestern Line of Archer Avenue 200 feet Northeast of the South Line of Lot 8 as measured along the said Northwestern Line; thence Northwest 152.30 feet on a line normal to said Northwestern Line of Archer Avenue; thence Northeast on a line normal to last said described line to a line 300 feet Westerly of and parallel to the East Line of said Lot 8; thence North or East said line to the North Line of said Lot 8, in County Clerk's Subdivision of Section 32, Township 37 North, Range 11, East of the Third Principal Meridian, according to the Plat thereof recorded April 7, 1987 as Document Number 87-183219, in Cook County, Illinois

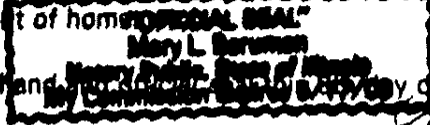
