TOGETHER WITH all the improvements now or herealter erected on the property, and all easements, appurtenances, and fixtures now or herealter a part of the property. All replacements and additions shall also be covered by this Security Instrument. All of the foregoing is referred to in this Security Instrument as the "Property".

BORROWER COVENANTS that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property and that the Property is unencumbered, except for encumbrances of record. Borrower warrants and will defend generally the title to the Property against all claims and demands, subject to any encumbrances of record.

If the ariount of the Funds held by Lender at any time is not sufficient to pay the Escrow Items when due, Lender may so notify Horrower in writing, and, in such case Borrower shall pay to Lender the amount necessary to make up the deficiency. Any forbearance by Lender in exercising any right or remedy shall not be a waiver of or proclude the exercise of any right or remedy.

The covenants and agreements of this Security Instrument shall bind and benefit the successors and assigns of Lender and Borrower, subject to the provisions of paragraph 17. Borrower's covenants and agreements shall be joint and several. Any Borrower who co-signs this Security Instrument but does not execute the Note: (a) is co-signing this Security Instrument only to mortgage, grant and convey that Borrower's interest in the Property under the torins of this Security Instrument; (b) is not personally obligated to pay the sums secured by this Security Instrument; and (c) agrees that Lender and any other Borrower may agree to extend, modify, torbear or make any accommodations with regard to the terms of this Security Instrument or the Note without that Borrower's consent.

If the default is not cured on or before the date specified in the notice, Lender at its opt in any require immediate payment in full of all sums second by this Security Instrument without further demand and use, foreclose this Security Instrument by Judicial proceeding. Lender shall be entitled to collect all expenses incurred in pursuing the remedies provided in this paragraph 21, including, but not fluited to, reasonable attorneys' tees and costs of title evidence.

Lender may charge Borrower a fee for releasing this Security Instrument, but only if the fee is part to a third party for services rendered and the charging of the fee is permitted under applicable law.
 - 23. Walver of Homestead. Borrower car is all right of homestead exemption in the Property.
- 24. Riders to this Security Instrument. If one or more riders are executed by Horrower and recorded together with this Security Instrument, the covenants and agreements of each such rider shall be incorporated into and shall amend and supplement the covenants and agreements of this Security instrument as if the inder(s) were a part of this Security Instrument.
