JUDGMENT

This action came on for trial before the Court, the Honorable Ronald Barliant, Bankruptcy Judge, presiding, and the issues having been duly tried, a decision having been duly rendered in the form of Findings of Facts and Conclusions of Law entered in this action on July 10, 1998 and the parties having stipulated and agreed to the calculation of damages thereunder, it is hereby ordered and adjudged as follows:

1. Judgment is hereby entered in favor of Universal Automotive, Inc.

("Universal") and against the Trustee on Counts I and III of the Trustee's First Amended Complaint (the "Complaint");

2. Judgment is hereby entered in favor of the Trustee and against Universal on Counts II, IV and V of the Complaint in the principal amount of \$195,027.00, together with prejudgment interest of \$48,906.48 plus per diem interest of \$23.31 for the period after July 20, 1998 through the date of judgment;

3. Judgment is hereby entered in favor of the Trustee and against Universal on Counts VI and VII of the Complaint in the principal amount of \$196,348.16, together with prejudgment interest of \$57,876.96 plus per diem interest of \$39.00 for the period after July 10, 1998 through the date of judgment; and

4. Judgment is hereby entered in favor of Universal and against the Trustee on both of Universal's counterclaims in the total amount of \$322,703.63 and, accordingly, Universal shall have an allowed claim against the Debtor's estate in that amount, subject to the requirements of the Bankruptcy Code, including Section 502(d). Universal shall not offset any portion of this judgment against the Trustee's foregoing judgments against Universal.
