## -ORDERMEMORANDUM OF JUDGMENT OF INDIRECT CIVIL CONTEMPT PENALTIES

Now comes the petitioner, the People of the State of Illinois, by and through their attorn y, Richard A. Devine. State's Attorney of Cook County, and requests this Court to make the following findings and order:

- 1. On the 24th day of June, 1997, and on the 19th day of August, 1997 this Court entered an order directing Respondent to remove the large amount of junk and debris from the subject property.
- 2. Respondent did not comply with the Court's order.
- 3. On December 9, 1997, a hearing was held wherein Respondent was afforded his rights to set forth his defenses and given an opportunity to make a full statement in allocation.
- 4. At the conclusion of that hearing, Respondent's failure to comply was found to be willful and contumacious and Respondent's conduct was found to have defeated and impaired the rights and interests of the petitioner and, further, impeded and obstructed the Court in its administration of justice.
- 5. Respondent was ordered to pay \$500.00 per day to the People of the State of Illinois through the Clerk of the Circuit Court of Cook County, as a penalty for the adjudged contumacious conduct, as long and until he has fully complied with the Court's order.
