a corporation organized and existing under the laws of the United States (hereinafter referred to as the Association) all  
the rents, issues and profits now due and which may hereafter become due under or by virtue of any lease, whether  
written or verbal, or any letting of or any agreement for the use or occupancy of any part of the following described  
premises:

The undersigned, do hereby irrevocably appoint the said Association management for the management of said property, and do hereby authorize  
the Association to let and relet said premises or any part thereof, according to its own discretion, and to bring or defend any suits in connection with  
said premises in its own name or in the name of the undersigned, as it may consider expedient, and to make such repairs to the premises as it may  
deem proper or advisable, and to do anything in and about said premises that the undersigned might lawfully do, without conflicting with anything

be deemed proper and advisable, hereby notifying and confirming all that the Association may do by virtue hereof. It being further understood and  
agreed that in the event of the exercise of this assignment, the undersigned will pay rent for the premises occupied by them at the rate of  
per month for each room, and a failure on their part to promptly pay said rent on the first day of each and every month shall, in and of itself  
constitute a forcible entry and detainer and the Association may in its own name and without notice or demand, institute an action of forcible  
entry and detainer and obtain possession of said premises. This assignment and power of attorney shall be binding upon and in the benefit of the  
heirs, executors, administrators, successors and assigns of the parties hereto and shall be construed as a covenant running with the land and shall  
continue in full force and effect until all of the indebtedness or liability of the undersigned to the said Association shall have been fully paid, at which  
time this assignment and power of attorney shall terminate.

It is understood and agreed that the Association will not exercise any of its rights under this Assignment until after default in the payment of any  
indebtedness or liability of the undersigned to the Association.


