his/her/their agents, heirs, successors or assigns, be and are permanently enjoined and restrained from renting, leasing, using or occupying the subject premises until there is full compliance with all open violations listed in the City's complaint; and said Defendant is ordered fully comply with all open violations (to wit, # 1 + 3) by 10/23/98.

2. The court reserves jurisdiction of this matter for the purposes of modification, enforcement or termination of this permanent injunction.

3. This order is final and appealable, the court finding no just cause or reason to delay its enforcement or appeal.

4. It is further ordered that this cause is hereby dismissed subject to the above injunctive orders.
