1. That on or about March 16, 1998 and at all relevant times, the Owner owned land in the County of Cook, State of Illinois, commonly known as 4900 First Avenue, McCook, Illinois, and with the following legal description:

2. That on or about March 16, 1998, the Owner entered into a written contract with Claimant to furnish labor and materials in relation to the installation of two new hydraulic pump units for the entry and exist sideguides on the 145" mill for and in said improvement on such premises for the sum of \$8,234.00.

3. That on or about May 9, 1998, Owner entered into a written agreement with Claimant pursuant to which Claimant performed additional work on such premises for the agreed sum of \$401.00. Claimant completed said extra work on or about May 9, 1998.

4. That on or about June 10, 1998, Claimant completed all required work under the contract.

5. That the Owner is entitled to credits in the amount of \$3,283.00.

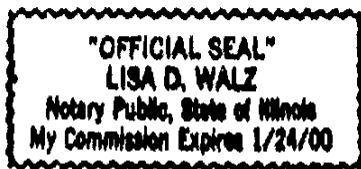
