SECOND MORTGAGE
MODIFICATION AGREEMENT

This Second Mortgage Modification Agreement ("Agreement") is dated as of July 12, 1998, and is between TCF National Bank Illinois & successor trustee KYMK Bank of Chicago, f/k/a Bank of Chicago/Garfield Ridge, not personally, but as Trustee under Trust Agreement dated January 4, 1990 and known as Trust No. 90-1-3 ("Mortgagor") and TCF National Bank Illinois, a national banking association, formerly known as Bank of Chicago, formerly known as Bank of Chicago, Garfield Ridge ("Mortgagor"), with an office located at 6353 West 55th Street, Chicago, Illinois 60638.

*BY MERGER TO

UNDERSTANDINGS

- A. Mortgagor executed a Mortgage and Security Agreement in favor of Mortgagee dated as of July 24, 1995, and recorded July 26, 1995, in the Cook County, Illinois Recorder of Deeds office as Document No. 95486544 ("Mortgage") encumbering the real estate described on Ex'abit A, attached hereto and made a part hereof. The Mortgage was amended by that certain First Modification Agreement dated as of March 12, 1996, and recorded March 26, 1996, in the Cook County, Illinois Recorder of Deeds office as Document No. 96230361, (the "First Amendment").
- B. The Mortgage secures the indebtedness, obligations and liabilities of Mortgagor pursuant to a promissory note in the original principal amount of \$450,000.00 dated July 24, 1995 payable to Mortgagee and executed jointly and severally by Mortgagor ("Note"), which Note was amended and restated it its entirety by that certain Amended and Restated Mortgage Note dated March 12, 1996 (the "Restated Note"). The Note and the Restated Note were have been further amended by that certain First Note Modification Agreement of even date necessith.
- C. The principal balance of the Note is due and payable on March 12, 2001. As of the date hereof, the outstanding principal balance due is \$392.496.59.
 - D. Mortgagor wishes to amend the terms of the Mortgage, and Mortgagee is willing to to so.

NOW, THEREFORE, in consideration of the Understandings set forth above, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Mortgagor and Mortgagee agree as follows:

- 1. The interest rate in effect on the Indebtedness Hereby Secured (as such term is defined in the Mortgage) is hereby reduced from eight and one-half percent (8.50%) to seven and three-quarters percent (7.75%). Such interest rate reduction shall be effective as of the date of this Agreement and shall continue until the Maturity Date as defined in the Restated Note.
- 2. Each reference in the Mortgage to the phrase "eight and one-half percent (8.50%)" shall be deleted and replaced with the following phrase "seven and three-quarters percent (7.75%)".
 - 3. In all other respects, the Mortgage shall remain unchanged and in full force and effect.
