6. Preservation and Maintenance of Property; Leaseholds; Condominiums; Planned Unit Developments. Any forbearance by Lender in exercising any right or remedy hereunder, or otherwise afforced by applicable law, shall not be a waiver of or preclude the exercise of any such right or remedy.

11. Successors and Assigns Bound; Joint and Several Liability; Co-signers. 15. Rehabilitation Loan Agreement. 18. Borrower's Right to Reinstate.
