(i) all rents received by Horrower shall be held by Horrower as trustee for benefit of Lender only, to be applied to the sums secured by the Security Instrument, (ii) Lender shall be entitled to collect and receive all of the rents of the Property, and (111) each tenance the Property shall pay all rents due and unpaid to I ender or I ender's agent on I ender's written demand to the tenant

Borrower has not executed any prior assignment of the rents and has not and will not perform any act that would prevent I ender from exercising its rights under this paragraph E.

I ender shall not be required to enter upon, take control of or maintain the Property before or after giving notice of breach to Borrower. However, Lender or a judicially appointed receiver may do so at any time there is a breach Any application of tents shall not cure or waive any default or invalidate any other right or remedy of Lender. This assignment of rents of the Property shall terminate when the debt secured by the Security Instrument of paid in full

G. CROSS-DEFAULT PROVISION. Borrower's default or breach under any note or agreement in which Lender has an interest shall be a breach under the Security Instrument and Lender may invoke any of the remedies permitted by the Security Instrument
