If the Index is no longer available, the Note Holder will choose a new index which is based upon comparable information. The Note Holder will give me notice of this choice.

(C) Calculation of Changes

Psion each Change Date, the Note Holder will calculate my new interest rate by adding six and \$75/1000ths percentage points (6.875 %) to the Current Index. The Note Holder vill then round the result of this addition to the nearest one-eighth of one percentage point (0.125%). Subject to the limits stated in Section 4(D) below, this rounded amount will be my new interest rate until the next Change Pate.
