ADDITIONAL COVENANTS. In addition to the covenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:

(A) Change Dates

If the Index is no longer available, the Note Holder will choose a new index which is based upon comparable information. The Note Holder will give me notice of this choice.

(C) Calculation of Changes

Brior each Change Date, the Note Holder will calculate my new interest rate by adding seven and 175/1000ths percentage points (7.375 %) to the Current Index. The Note Holder will be round the result of this addition to the nearest one-eighth of one percentage point (0.125%). Subject to be limits stated in Section 4(D) below, this rounded amount will be my new interest rate until the next Change Date.

The Note Holder will then determine the amount of monthly payment that would be sufficient to repay the unpaid principal that the expected to owe at the Change Date in full on the maturity date at my new interest rate in substantially equal payments.
