MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE IS DATED SEPTEMBER 16, 1998, BETWEEN Maywood-Proviso State Bank as Trustee U/T/A dtd March 23, 1991 A/K/A Trust No. 8741 (referred to below as "Grantor"), whose address is 411 Madison Street, Maywood, IL 60153; and LASALLE BANK NATIONAL ASSOCIATION (referred to below as "Lender"), whose address is 4747 WEST IRVING PARK ROAD, CHICAGO, IL 60641.

MORTGAGE. Grantor and Lender have entered into a mortgage dated April 30, 1997 (the "Mortgage") recorded in Cook County, State of Illinois as follows:

It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the
