#### LOAN MODIFICATION AGREEMENT

THIS AGREEMENT, is made and entered into as of August 24, 1998, but made effective as of August 1, 1998. by and between MID TOWN BANK AND TRUST COMPANY OF CHICAGO, an Illinois corporation ("BANK") & CHERYL SLOANE C'BORROWER").

#### WHEREAS:

- The BORROWER has heretofore executed a Promissory Note dated July 21, 1995, in the principal amount 1. of \$141,600,00 ("NOTE"), of which the BANK is presently the holder:
- the NOTE is secured by a Mortgage, Assignment of Rents & Security Agreement (Chattel Mortgage) dated July 21, 1995, and recorded in the Recorder's Office of Cook County, Hinois, as document number 95484271 ("MORTGAGE"), placing a mortgage lien on certain real estate described in Exhibit "A" attached hereto and by this reference incorporated herein (RFM FSTATE");
- The BANK has disbursed to BORROWER the sum of \$141,600.29, which amount represents the entire 3 principal sum of the indebtedness evidenced by the NOUE. SOM
- The interest rate evidenced on said NOTE is 6.5%; -
- 5 The maturity date evidenced on said NOTE is August 1, 1998:
- The BORROWLR desires to amend the loan amount, interest rate, payment amount, and maturity 0 date as evidenced by the NOTE:
- The BANK has agreed to such modification pursuant to the terms and conditions of a commitment of the 7. BANK dated August 20, 1998 ("COMMITMENT").

NOW THEREFORE, notwithstanding anything contained in the NOTE and MORTGAGE, and in consideration of the mutual covenants, conditions, and premises contained herein, the PARTIES HERETO AGREE AS FOLLOWS:

- A. The principal amount evidenced by the NOTE as of the effective date is \$136,526.75.
- B. The interest rate evidenced by the NOTE as of the effective date is 6.875%

- C. Principal and interest payments in the amount of \$896.88 (based on a 30 year amortization) shall be due and payable monthly beginning September 1, 1998, and on that day each month thereafter until all of said outstanding principal plus any remaining accrued interest and late charges, if any, are repaid in full.
- D. The maturity date is hereby amended to August 1, 2003.
- E. Except as modified herein, the terms, covenants and conditions of the MORTGAGE shall remain unchanged and otherwise in full force and effect. In the event of any inconsistency between the terms of this agreement and the terms of the NOTE and or MORTGAGE, the terms herein shall control.
- F. The lien of the NORTGAGE IS hereby modified as security for the payment of the principal sum evidenced by the NOTE and openhed by this MODELICATION AGREEMENT
- G. This agreement shall be governed by and construed under the laws of the State of Illinois.
