

**MODIFICATION
OF LOAN

MORTGAGE DATED
JUNE 1, 1998**

This agreement made this 01st day of August, 1998, between FIRST MIDWEST MORTGAGE CORPORATION (as agent for Banc Group Mortgage Corporation) (LENDER), and Alan E. White and Yvonne M. White, his wife, (BORROWERS), WITNESSETH:

That the parties hereto agree to modify the terms of a certain note dated the 01st day of June, 1998, secured by a mortgage of the same date, recorded as Document # 98490011, of the records of Cook County, Illinois, and conveying the real estate described as:

That the remaining indebtedness represented by said note and mortgage is \$ 71,897.02. That said indebtedness shall be paid in monthly payments of \$490.85, which shall include interest at the rate of 7.250% per annum, and that in addition, said BORROWERS will pay the sum per month equal to 1-12 of the estimate to be sufficient to pay taxes and insurance on said property, which estimate may be revised. First payment beginning September 01, 1998 and continuing thereafter until the new maturity day of ~~September 01, 2028.~~

That this AGREEMENT supplements the above described note and mortgage. That all terms contained in said note and mortgage shall remain in full force and effect, except those herein expressly modified and that the BORROWERS agree that they will perform and observe the covenants and conditions of said note and mortgage so modified and that they will pay the interest and principal secured by said mortgage when due.

That the terms of this AGREEMENT shall be binding upon the heirs, personal representatives, and assigns of the BORROWERS.

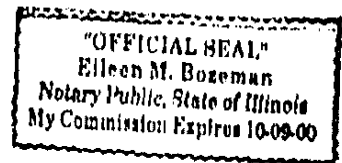
