NOW, THEREFORE, to secure (a) the payment of the indebtedness evidenced by the Note, together with interest thereon and any fees in connection therewith (the "Indebtedness"), (b) the repayment of any advances or expenses of any kind incurred by Mortgagee pursuant to the provisions of or on account of the Note or this Mortgage, (c) the repayment of future advances, if any, disbursed by Mortgagee to Mortgagor in accordance with the terms of the Mortgage or the Note in excess of the principal amount of the Indebtedness, and (d) the performance and observance of all of the terms, covenants, provisions and agreements of this Mortgage, the Note and all other documents now or hereafter executed in connection with the Indebtedness (collectively, the "Loan Documents"), all of the foregoing not to exceed the amount of \$\frac{588,000.00}{588,000.00}\$, the Mortgagor hereby agrees as follows:

ARTICLE I GRANT

1.01 The Mortgagor hereby grants, bargains, sells, releases, conveys, assigns, transfers, mortgages and confirms unto the Mortgagee, and grants a security interest in, the real estate described in Exhibit A attached hereto and made a part hereof (the "Real Estate"), which with the property, estates and interests hereinafter described is referred to herein as the "Property";

Together with, all rents, issues, profits, royalties, income and other benefits derived from the Real Estate, subject to the right, power and authority hereinafter given to Mortgagor to collect and apply such rents;

ARTICLE II

- 2.01 Mortgagor represents that it has good and narketable title to the Property. Mortgagor represents that it has good right and full power to sell and convey the saine and that it has duly executed and delivered this Mortgage pursuant to proper directions and that Mortgagor will make any further assurances of title that the Mortgagee may require and will defend the Property against all claims and dimends whatsoever.
- 2.02 Mortgagor represents that the proceeds of the loan evidenced by the Note will be used for the purposes specified in Paragraph 6404 of Chapter 17 of the Illinois Revised Statutes and that the principal sum evidenced by the Note constitutes a business loan which comes within the purview of such paragraph.
- 2.03 Neither Mortgagor nor, to the best of Mortgagor's knowledge, any previous owner of the Property or any third party, has used, generated, stored or disposed of any Hazardous Substances or the Property. For the purposes of this representation and warranty. Hazardous Substances shall include, but shall not be limited to, any toxic or hazardous wastes, pollutants or substances, including, without limitation, asbestos, PCBs perroleum products and by-products, substances defined or listed as hazardous substances or toxic substances or limited v identified in or pursuant to the Comprehensive Environmental Response, Compensation and Liability Act of 1950, as amended, 42 U.S.C. 4 9601 et seq., hazardous materials identified in or pursuant to the Hazardous Materials Transportation Act, 49 U.S.C. à 1802 et seq., hazardous wastes identified in or pursuant to The Resource Conservation and Recovery Act, 42 U.S.C. á 6901 et seq., any chemical substance or mixture regulated under the Toxic Substance Control Act of 1976, as amended, 15 U.S.C. à 2601 et seq., any toxic pollutant under the Clean Water Act, as amended, 33 U.S.C. á 1251 et seq., any hazardous air pollutant under the Clean Air Act, 42 U.S.C. á 7401 et seq., and any hazardous or toxic substance or pollutant regulated under any other applicable federal, state or local environmental health or safety laws, regulations or rules of common law. ARTICLE III WAIVER OF REDEMITION

3.01 Mortgagor acknowledges that the Real Estate does not constitute agricultural real estate as said term is defined in Section 15-1201 of the Illinois Mortgage Foreclosure Law (the "Act") or residential real estate as defined in Section 15-1219 of the Act. Mortgagor hereby waives any and all rights of redemption under judgment of foreclosure of this Mortgage on behalf of Mortgagor, and on behalf of each and every person acquiring any interest in or title to the Real Estate or of any nature whatsoever subsequent to the date of this Mortgage. The foregoing waiver of right of redemption is made pursuant to the provisions of Section 15-160(B) of the Act. To the fullest extent permitted under applicable law, Mortgagor shall not, and will not, apply for or avail itself of any appraisement, valuation, stay, extension or exemption law, or so-called "Moratorium Laws," now existing or hereafter exacted, in order to prevent or hinder the enforcement or foreclosure of this Mortgage, but hereby waives the benefit of such laws. Mortgagor for itself and all who may claim through or under it waives any and all right to have the Real Estate, and any estates comprising the Real Estate, marshalled upon any foreclosure of the lien hereof agrees that any court having jurisdiction to foreclose such lien may order the Real Estate sold as an entirety.

ARTICLE IV MORTGAGOR'S COVENANTS

- 4.01 Mortgagor covenants and agrees to pay the Indebtedness and the other sams secured hereby in the manner and at the times provided for in the Lorn Documents.
- 4.02 Mortgagor covenants and agrees to pay or couse to be paid, when due and payable by Mortgagor:
 - (a) all real estate taxes, personal property 'axis, assessments, license fees, water and sewer rates and charges, and all other governmental levies and charges, of every kind and nature whatsoever, general and special, ordinary and extraordinary, unforeseen as well as foreseen, which shall be assessed, levied, confirmed, imposed or become a lien upon or against the Property or any portion thereof, and all taxes, assessments and charges upon the rents, issues, income or profits of the Property, or which shall become payable with respect thereto or with respect to the occupancy, use or possession of the Property, whether such taxes, assessments or charges are levied directly or intaltectly (hereinafter collectively called the "Impositions"); and
 - (b) all other payments or charges required to be paid to comply with the terms and provisions of this Mortgage.

Within ten (10) days after written demand therefor, Mortgagor shall deliver to Mortgagee the original, or a photostatic copy, of the official receipt evidencing payment of Impositions or other proof a payment satisfactory to Mortgagee. Failure of Mortgagor to deliver to Mortgagee said receipts or to submit other proof satisfactory to Mortgagee as aforesaid shall constitute an Event of Default hereunder.

4.03 Mortgagor covenants and agrees to keep and maintain, or cause to be kept and maintained, the Property (including all improvements thereon and the sidewalks, sewers, and curbs) in good order and condition and will make or cause to be made, as and when the same shall become necessary, all structural and nonstructural, ordinary and extraordinary, foreseen and unforeseen repairs and all maintenance necessary to that end. Furthermore, and without limiting the generality of the foregoing, Mortgagor will suffer no waste. All repairs and maintenance required of Mortgagor shall be (in the reasonable opinion of Mortgagee) of first-class quality.

- 4.04 Mortgagor covenants and agrees that this Mortgage is and will be maintained as a valid mortgage lien on the Property and that Mortgagor will not, directly or indirectly, create or suffer or permit to be created, or to stand against the Property, or any portion thereof, or against the rents, issues and profits therefrom, any lien (including any liens arising with respect to the payment of Impositions), security interest, encumbrance or charge whether prior to or subordinate to the lien of this Mortgage unless written approval is first obtained from Mortgagee. Mortgagor will keep and maintain the Property free from all liens of persons supplying labor and materials for the construction, modification, repair or maintenance of any building or site improvement whether or not on the Property.
- 4.05 Mortgagor covenants and agrees, so long as the Indebtedness remains outstanding, to comply with all regulations, rules, ordinances, statutes, orders and decrees of any governmental authority or court applicable to the Mortgagor or applicable to the Property or any part thereof and will promptly cure any violation of law and comply with early order of any such governmental authority or court, including, without limitation, in respect of the repair, replacement or condition of the Property and any governmental regulations concerning environmental control and improvements.
- 4.06 Mortgagor coverant's and agrees that all awards heretofore or hereafter made by any public or quasi-public authority to the present ant' at subsequent owners of the Property by virtue of an exercise of the right of eminent domain by such authority, including any award for a taking of title, possession or right of access to a public way, or for any change of grade of street effecting the Property, are hereby assigned to the Mortgagee.
- 4.07 Mortgagor covenants and agrees that neither the value of the Property nor the lien of this Mortgagor will be materially diminished or impaired in any way by any act or omission of the Mortgagor, and the Mortgagor agrees it will not do or permit to be done to, in, upon or about said Property, or any part thereof, anything that may in any way impair the value thereof, or weaken, diminish, or impair the security of this Mortgage.
- 4.08 Mortgagor covenants and agrees that if any action of proceeding is commenced in which Mortgage in good faith deems it necessary to defend or uphold the validity, enforceability or priority of the lien and interest of this Mortgage or to preserve the value of the security for this Mortgage, all sums paid by Mortgagee for the expense of any such litigation to prosecute or defend the rights, lien and security interest created by this Mortgage (including reasonable attorneys' fees) shall be paid by Mortgagor, together with interest thereon at the rate then applicable under the Note, and any such sums and the interest thereon shall be a lien and security interest on the Property prior to any right or title to, interest in or claim upon the Property attaching or accruing subsequent to the lien and security interest of this Mortgage, and shall be secured by this Mortgage.

ARTICLE V TRANSFER OR MORTGAGE OF PROPERTY

5.01 Mortgagor will not, without the prior written consent of Mortgagee, further mortgage, grant a deed of trust, pledge or otherwise dispose of or further encumber, whether by operation of law or otherwise, any or all of its interest in the Property. Mortgagor will not, without the prior written consent of Mortgagee, sell, assign, or transfer the Property or any interest therein. Any sale, assignment, transfer, mortgage, deed of trust, pledge, change or other disposition or encumbrance made in violation of the above provisions shall be null and void and of no force and effect and the making thereof shall constitute an Event of Default hereunder.

ARTICLE VI PERFORMANCE OF MORTGAGOR'S OBLIGATIONS

6.01 Upon the occurrence of an Event of Default under this Mortgage, then, without limiting the generality of any other provision of this Mortgage, and without waiving or releasing Mortgagor from any of its obligations hereunder, Mortgagee shall have the right, but shall be under no obligation, to pay any Impositions or other payment, or any sums due under this Mortgage, and may perform any other act or take such action as may be appropriate to cause such other term, covenant, condition or obligation to be promptly performed or observed on behalf of Mortgagor. In any such event, Mortgagee and any person designated by Mortgagee shall have, and is hereby granted, the right to enter upon the Property at any time and from time to time for the purposes of performing any such act or taking any such action, and all moneys expended by Mortgagee in connection with making such payment or performing such act (including, but not limited to, legal expenses and disbursements), together youth interest thereon at the default rate set forth in the Note from the date of each such expenditure, shall be paid by Mortgagor to Mortgagee within ten (10) days after written notice to Mortgagor demanding such payment, and shall be secured by this Mortgage, and Mortgagee shall have the same rights and remedies in the event of nonpayment of any such sums by Mortgagor as in the case of a default by Mortgagor in the payment of the Indebtedness. Nothing in this Section or in any other part of this Mortgage shall be construed to require Mortgagee to make any payment or perform any obligation of Mortgagor. Any action taken by Mortgagee hereunder or in relation with Property is for the sole benefit of Mortgagee and no other person shall rely upon any action, inaction, inspection or other act of Mortgagee in dealing with the Property or Mortgagor. Upon the occurence of an Event of Default under this Mortgage, (a) in making any payment hereby authorized relating to taxes and assessments, Mortgagee may do so according to any bill, statement or estimate procured from the appropriate public office without inquir/ it to the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax her or title or claim thereof, or (b) in making any payment hereby authorized for the purchase, discharge, compromise or settlement of any other lien, Mortgagee may do so without inquiry as to the validity or amount of any claim for lie) which may be asserted.

ARTICLE VII ASSIGNMENT OF LEASES, REN 5 AND CONTRACTS

7.01 Mortgagor hereby assigns to Mortgagee all of Mortgagor's laterest in all rents, issues and profits of the Property, as further security for the payment of the Indebtedness and other sums secured hereby. Mortgagor grants to Mortgagee the right to enter the Property and to let the Property, or any part thereof, and to apply said rents, issues, profits and proceeds after payment of all charges and expenses, or account of the Indebtedness and other sums secured hereby. This assignment and grant shall continue in effect of the Indebtedness and other sums secured hereby are paid in full. Mortgagee hereby agrees not to exercise the right to enter the Property for the purpose of collecting said rents, issues or profits, and Mortgagor shall be entitled to collect and receive said rents, issues, profits and proceeds, until the occurrence of an Event of Default hereunder; provided, that any rents, issues and profits collected and received by Mortgagor after the occurrence of an Event of Default hereunder shall be deemed collected and received by Mortgagor in trust for Mortgagee and Aprigagor shall account to Mortgagee for the full amount of such receipts. Mortgagor agrees to apply said rents, issues and profits, whenever received, to payment of the Indebtedness, all Impositions on or against the Property and other sums secured hereby.

7.02 The assignment contained in this Article VII is given as collateral security and the execution and delivery hereof shall not in any way impair or diminish the obligations of the Mortgagor, nor shall this assignment impose any obligation on Mortgagee to perform any provision of any contract pertaining to the Property or any responsibility for the non-performance thereof by Mortgagor or any other person. The assignment under this Article VII is given as a primary pledge and assignment of the rights described herein and such assignment shall not be deemed secondary to the security interest and Mortgage of Mortgagee in the Property. Mortgagee shall have the right to exercise any rights under this Article VII before, together with, or after exercising any other rights under this Mortgage.

7.03 Mortgagor shall observe and perform all covenants, conditions and agreements in each lease to which it is a party and that now or hereafter affects any portion of the Property. Mortgagor shall not, without the prior written consent of Mortgagee, (a) accept any installments of rent for more than one month in advance or any security deposit for more than an amount equal to two months' rent, or (b) take any action or fail to take any action or exercise any right or option which would permit the tenant under any lease to cancel or terminate such lease, or (c) amend or modify any lease in a manner which would (i) decrease the rent payable per unit of time under the lease, (ii) decrease the payments to be made by the tenant under the lease for rent, taxes, insurance or other expenses, (iii) decrease the term of the lease, (iv) impose any additional obligations on the landlord under the lease, or (v) consent to a sublease or a substitution of tenants under the lease. Mortgagor agrees that hereafter it shall not assign any of the rents or profits of the Property.

7.04. Noting herein contained shall be construed as constituting Mortgagee a mortgagee in possession in the absence of the taking of actual possession of the Property by Mortgagee pursuant to Article IX hereof. In the exercise of the powers herein granted Mortgagee, no liability shall be asserted or enforced against Mortgagee, all such liability being encressly waived and released by Mortgagor.

ARTICLE VIII DEFAULT

- 8.01 The occurrence of any one or nore of the following events shall constitute an event of default (each, an "Event of Default") under this Mortgage:
 - (a) Failure of Mortgagor to observe or perform any of the covenants or conditions by Mortgagor to be performed under the terms hereof, which is not remedied within any applicable cure period.
 - (b) Nonpayment of principal under the Note when the, or nonpayment of interest under the Note or of any other obligations under any of the Loan Documents within five days after the same becomes due.
 - (c) The occurrence of a default under any Loan Document, which is not remedied within any applicable cure period.
 - (d) Any warranty or representation of Mortgagor made hereunder was inaccurate or misleading in any material respect when made.
- 8.02 If an Event of Default shall occur which is not cured within any applicable grace period provided for. Mortgagee may, at its option, exercise any and all of the following remedies under this Mortgage:
 - (a) Declare the unpaid portion of the Indebtedness to be immediately due and payable a cording to the terms of the Note.
 - (b) Enter upon the Property and take possession thereof and of all books, records and accounts relating thereto.
 - (c) Appoint a receiver for the Property, or any part thereof, and of the net income, rents, issues and profits thereof, without regard to the sufficiency of the Property covered by this Mortgage or any other security, and without the showing of insolvency on the part of Mortgagor or fraud or mismanagement, and without the necessity of filing any judicial or other proceeding for appointment of a receiver.

- (d) Hold, lease operate or otherwise use or permit the use of the Property, or any portion thereof, in such manner, for such time and upon such terms as Mortgagee may deem to be in its best interest (making such repairs, alterations, additions and improvements thereto, from time to time, as Mortgagee shall deem necessary or desirable) and collect and retain all earnings, rentals, profits or other amounts payable in connection therewith.
- (e) Sell the Property, in whole or in part:
 - (i) under the judgment or decree of a court of competent jurisdiction, or
 - (ii) sell any of the Collateral (as defined in Article XIII), in whole or on part, at public auction (if permitted by law) in such manner, at such time and upon such terms as Mortgagee may determine, or at one or more public or private sales, in such manner, at such time or times, and upon such terms as Meanagee may determine or as provided by law.
- (f) Forestore this Mortgage.
- (g) Exercise any other remedy now or hereafter existing in equity, at law, by virtue of statute or otherwise.
- 8.03 In case Mortgagee shall have proceeded to enforce any right under the Note or this Mortgage and such proceedings shall have been discontinued or abandoned for any reason, then in every such case Mortgagor and Mortgagee shall be restored to their former positions and the right, remedies and powers of Mortgagee shall continue as if no such proceedings had been train.
- 8.04 In the event Mortgagee (a) grants an extension of time on any payments of the Indebtedness, (b) takes other or additional security for the payment thereof, or (c) wa'ves or fails to exercise any right granted herein, said act or omission shall not release Mortgagor, subsequent purchasers of the Property covered by this Mortgage or any part thereof, or any guarantor of the Note.

ARTICLE IX **FORECLOSURE**

9.01 In any suit to foreclose the lien hereof, there shall be allowed and included as additional indebtedness in the decree of sale all expenditures and expenses which may be paid or incurred by or on behalf of Mortgagee, or holders of the Note, for reasonable attorneys' fees, court costs, appraisers' fees, carrays for documentary and expert evidence, stenographers' charges, publication costs and costs of procuring tide insurance policies (which fees, charges and costs may be estimated as to items to be expended after entry of the operee), and all other expenses as Mortgagee or holders of the Note may deem reasonably necessary to prosecute such suit or to evidence to bidders at any sale which may be had pursuant to such decree the true condition on the value of the Property. All expenditures and expenses of such nature in this Article mentioned shall become so much additional Indebtedness secured hereby and shall be immediately due and payable with interest thereon at the rate in effect under the Note when paid or incurred by Mortgagee or holders of the Note. In addition to foreclosure proceedings, the above provisions of this paragraph shall apply to (a) any proceeding to which Mortgagee or the holders of the Note shall be a party, either as plaintiff, claimant or defendant, by reason of this Mortgage or any Indebtedness hereby secured; (b) preparations for the commencement of any suit for foreclosure hereof after accrual of such right to foreclosure whether or not actually commenced; or (c) preparation for the defense of or investigation of any threatened suit, claim or proceeding which might affect the Property or the security hereof, whether or not actually commenced.

9.02 Upon or at any time after the filing of a bill to foreclose this Mortgage, the court in which such bill is filed may appoint a receiver of the Property. Such appointment may be made either before or after sale, without notice, without regard to the solvency or insolvency at the time of application for such receiver of the person or persons, if any, liable for the payment of the Indebtedness and other sums secured hereby and without regard to the then value of the Property and the Mortgagee hereunder may be placed in possession of the Property. The receiver shall have power to collect the rents, issues and profits of the Property during the pendency of such foreclosure suit, as well as during any further times when Mortgagee, its successors or assigns, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits, and other powers which may be necessary or are usual in such cases for the protection, possession, control, management and operation of the Property during the whole of said period. The court from time to time may authorize the receiver to apply the net income in his hands in payment in whole or in part of the Indebtedness and other sums secured hereby, or in payment of any tax, special assessment or other lien which may be or become superior to the lien hereof or superior to a decree foreclosing this Mortgage, provided such application is made prior to foreclosure sale.

- 9.03 The piece ds of any sale of all or any portion of the Property and the earnings of any holding, leasing, operating or other use of the Property shall be applied by Mortgagee in the following order:
 - (a) first, to the payment to Mortgagee of the costs and expenses of taking possession of the Property and of holding, using, leaving, repairing, improving and selling the same;
 - (b) second, to the payment of Mortgagee's attorneys' fees and other legal expenses;
 - (c) third, to the payment of accrn ed and unpaid interest on the Note;
 - (d) fourth, to the payment of the balance of the Indebtedness; and
 - (e) any surplus shall be paid to the parties entitled to receive it.

ARTICLE Y. INSPECTION

10.01 Mortgagor covenants and agrees that Mortgagee, or its recalls or representatives, may make such inspections of the Property as Mortgagee may deem necessary or desirable, at all reasonable times and that any such inspections shall be solely for the benefit of Mortgagee and shall not be relied upon by Mortgagor for any purpose.

ARTICLE XI ASSIGNMENT BY MORTGAGEE

11.01 Mortgagee may assign all or any portion of its interest hereunder and its rights granted herein and in the Note to any person, trust, financial institution or corporation as Mortgagee may determine and roon such assignment, such assignee shall thereupon succeed to all the rights, interests, and options of Mortgagee herein and in the Note contained and Mortgagee shall thereupon have no further obligations or liabilities hereunder.

ARTICLE XII INSURANCE

12.01 (a) Mortgagor will procure, deliver to and maintain for the benefit of Mortgagee during the continuance of this Mortgage and until the same is fully satisfied and released, a policy or policies of insurance insuring the

buildings, structures and improvements now existing or hereafter created on said Property against loss or damage by fire, lightning, windstorm, hail, explosion, riot, civil commotion, aircraft, vehicles, smoke, and such other hazards, casualties, and contingencies as Mortgagee may designate. All policies of insurance required hereunder shall be in such form, companies, and amounts as may be acceptable to Mortgagee, and shall contain a mortgagee clause acceptable to Mortgagee, with loss payable to Mortgagee. Mortgagor will promptly pay when due, any premiums on any policy or policies of insurance required hereunder, and will deliver to Mortgagee renewals of such policy or policies at least ten (10) days prior to the expiration dates thereof; the said policies and renewals to he marked "paid" by the issuing company or agent. Upon Mortgagor's failure to comply with the requirements of this paragraph, Mortgagee may, in its discretion, effect any insurance required hereunder and pay the premiums due therefor, and any amounts so paid by Mortgagee shall become immediately due and payable by Mortgagor with interest as described in Section 6.01 hereof, and shall be secured by this Mortgage. The delivery to Mortgagee of any policy or policies of insurance hereunder, or renewals thereof, shall constitute an assignment to Mortgagee of any uncarned premiums thereon as further security for the payment of the Indebtedness. In the event any foreclosure action or other proceeding hereunder is instituted by Mortgagee, all right, title and interest of Mortgagor in any of to any policy or policies of insurance then in force shall vest in Mortgagee.

- (b) Mortgagor shall open and keep in force during the term of this Mortgage public liability insurance, flood insurance, if applicable, and such other types of insurance in such amounts and in such form as Mortgagee shall require. Such insurance shall name Mortgagee as a co-insured and shall provide that it may not be cancelled or materially modified except after 35 days' prior written notice to Mortgagee. Mortgagor shall deliver evidence of such insurance to Mortgagee in such form and at such times as Mortgagee may reasonably require.
- 12.02 (a) In case of damage to or the destriction of the improvements on the Property by fire or other casualty. Mortgagor may, at Mortgagor's election exercised within 30 days after the occurrence of loss or casualty (provided no Event of Default has occurred), cause all proceeds of insurance to be applied to the Indebtedness or the restoration to their former condition of the improvements damaged or destroyed; provided, that Mortgagor's right to elect to have the proceeds applied to restoration of the improvements shall be conditioned upon the Mortgagor's presenting to Mortgagee concurrently with notice of Mortgagor's election, evidence reasonably satisfactory to Mortgagor that (i) the proceeds of insurance are sufficient to repair or restore improvements, or, if such proceeds are insufficient, that Mortgagor has deposited viril Mortgagor can complete such repairs or restoration prior to the date when the Note becomes due and payable. In the event Mortgagor does not or is not entitled to make the election aforesaid, Mortgagee may decide whether the insurance proceeds shall be applied against the Indebtedness or in the repair or restoration of the improvements.
- (b) In the event the insurance proceeds are to be applied to the Indebtedness. Mor gage may collect all proceeds of insurance after deduction of all reasonable expenses of collection and settlement, including attorneys' and adjustors' fees and charges, and apply same against the Indebtedness. If the proceeds are including attorneys and Indebtedness in full, Mortgagee may declare the balance remaining unpaid immediately due and payable, and avail itself of any of the remedies provided for upon the occurrence of any Event of Default. Any proceeds remaining after application upon the Indebtedness shall be paid by Mortgagee to Mortgagor.
- (c) In the event the insurance proceeds are to be used to rebuild the improvements, Mortgagee may collect and retain the insurance proceeds and disburse same. ARTICLE XIII SECURITY AGREEMENT

- 13.03 Mortgagee shall give Mortgagor notice by registered mail, postage prepaid, of the time and place of any public sale of any of the Collateral or of the time at er which any private sale or other intended disposition thereof is to be made by sending notice to Mortgagor at least tive days before the time of the sale or other disposition, which provisions for notice Mortgagor and Mortgagee agree are reasonable; <u>provided</u>, that nothing herein shall preclude Mortgagee from proceeding as to both Real Estate and property in accordance with Mortgagee's rights and remedies in respect to the Real Estate as provided it. Section 9-50l(4) of Chapter 26 of the Illinois Revised Statutes.
- 13.04 Mortgagor shall reimburse Mortgagee for all costs, charges and fee, including legal fees incurred by Mortgagee in preparing and filing security agreements, extension agreements, financing statements, continuation statements and chattel searches.
- 13.05 The Collateral described herein shall be considered for all purposes a part of the Property as described herein; all warranties and covenants contained in this Mortgage made by Mortgagor shall be deemed as having been made with reference to the Collateral; all agreements, undertakings and obligations of Mortgagor stated herein shall apply to the Collateral, including without limitation, obligations regarding insurance irredom from adverse lien or encumbrance, repair and maintenance; and all remedies of the Mortgagee in the event of any Event of Default hereunder shall be available to the Mortgagee against the Collateral.

14.07 If one or more of the provisions of this Mortgage shall be invalid, illegal or unenforceable in any respect, such provision shall be deemed to be severed from this Mortgage and the validity, legality and enforceability of the remaining provisions contained herein shall not in any way be affected or impaired thereby. Without limiting the generality of the foregoing, any provision herein, or in the Note to the contrary notwithstanding, Mortgagee shall in no event be entitled to receive or collect, nor shall or may amounts receive hereunder be credited, so that Mortgagee shall be paid, as interest, a sum greater than the maximum amount permitted by law.
