MORTGAGE

THIS MORTGAGE IS DATED AUGUST 14, 1959, hatween Cole Taylor Bank, as Trustee, whose address is 850 W. Jackson Bivd., Chicago, IL 60607 (referred to below as "Grantor"); and COLE TAYLOR BANK, whose address is One Yorktown Center, Lombard, IL 60148 (referred to below as "Lender").

GRANT OF MORTGAGE. DUE ON SALE - CONSENT BY LENDER. The following shall constitute taxes to which this section applies: (a) a specific tax upon this type of Mortgage or upon all or any part of the indebtedness secured by this Mortgage; (b) a specific tax on Grantor which Grantor is authorized or required to deduct from payments on the indebtedness secured by this type of Mortgage; (c) a tax on this type of Mortgage chargeable against the Lender or the holder of the Note; and (d) a specific tax on all or any portion of the indebtedness or on payments of principal and interest made by Grantor.

Subsequent Taxes.
