insurance, plus one-twelfth of yearly premium installments for mortgage insurance, if any, all as reasonably estimated initially and from time to time by Lender on the basis of assessments and bills and reasonable estimates thereof.

The funds shall be held in an institution the deposits or accounts of which are insured or guaranteed by a Federal or State Agency (including Lender if Lender is such an institution). Lender shall apply the Funds to pay said taxes, assessments, insurance premiums and ground rents. Lender may not charge for so holding and applying the Funds, analyzing said account or verifying and compiling said assessments and bills, unless Lender pays Borrower interest on the Funds and applicable law permits Lender to make such a charge. B. Set forth below is a list of events which, upon the lapse of the applicable grace period, if any, shown paralelly after such event, will constitute an Event of Default: (1) Borrower's failure to pay when due any amounts due under the Credit Document (30 day grace period); (2) Lender's receipt of actual knowledge of any material misrepresentation by Borrower in connection with the line of credit, whether contained in or omitted from Borrower's credit application or committed during the term of the Note (no grace period); (3) Borrower's material status and the transfer of Borrower's interest in the Collateral (as such term is defined in the Security Agreement) to someone who is a signor of all the Credit Documents, if any, and, as a result thereof, Lender's sale or transfer of, or promote to sell or transfer, all or any part of the Property or any interest therein, or any interest in the Collateral, whether voluntary or involuntary, without Lender's prior written consent (no grace period); (5) the security for the Note or any rights of the Lender is such security as adversely affected (no grace period); (4) Borrower's failure to pay any amount due under the Note or any part of the Note (no grace period).

16. **TRANSFER OF PROPERTY.** Upon the occurrence of an Event of Default as specified in Paragraph 15.B(4) above. Lender shall be entitled to immediately accelerate the amounts due under the Note and declare all indebtedness secured by this Mortgage to be immediately due and payable. Failure to pay such indebtedness within thirty (30) days after notice to Borrower of such acceleration shall constitute an Event of Default. Any use or attempted use by Borrower of the revolving line of credit evidenced by the Note after such an Event of Default shall constitute a separate Event of Default.

As an alternative to declaring all sums secured by this Mortgage to be immediately due and payable, Lender may waive its option to accelerate and agree in writing, prior to close of the sale or transfer to the transferee's assumption of the outstanding obligation under the Note, on terms satisfactory to Lender, subject to Lender's right, described in Paragraph 6.D of the Note, to freeze or reduce the line of credit. Further advances on the line of credit will cease as of the date of the written assumption agreement signed by the transferee and Lender. The transferee and Borrower shall retain the right to repay the Note before the final payment date set forth in Paragraph 4 of the Note, in whole or in part, at any time without premium or penalty.

17. **ACCELERATION; REMEDIES (INCLUDING FREEZING THE LINE).** Upon the existence of an Event of Default Lender may, at its sole option, terminate the line, declare all of the sums secured by this Mortgage to be immediately due and payable without further demand, and invoke any remedies permitted by applicable law.
