RENO and ROSE RENO, Trustees under the LEONARD L. RENO and ROSE RENO DECLARATION OF TRUST dated and any amendments thereto, GRANTEES, (hereinafter referred to as "said Trustee," regardless of the number of trustees; and unto all and every successor or successors in trust under said trust agreement, the following described real estate in the County of Cook and State of Illinois, to wit:
