13. REMEDIES ON DEFAULT. In some instances, federal and state law will require Lender to provide Mortgagor with notice of the right to cure or other notices and may establish time schedules for foreclosure actions. Subject to these limitations, if any, Lender may accelerate the Secured Debt and foreclose this Security Instrument in a manner provided by law if Mortgagor is in default. Upon default, Lender shall have the right, without declaring the whole indebtedness due and payable, to foreclose against all or part of the Property. 

14. EXPENSES; ADVANCES ON COVENANTS; ATTORNEYS' FEES; COLLECTOR COSTS. Except when prohibited by law, Mortgagor agrees to pay all of Lender's expenses if Mortgagor breaches any covenant in this Security instrument. Mortgagor will also pay on demand any amount incurred by Lender for insuring, inspecing, preserving or otherwise protecting the property and Lender's security interest in the property described below. By not exercising any remedy on Mortgagor's default, Lender does not waive Lender's right to later exercise foreclosure proceedings if Lender fails to waive Lender's right to require complete cure of any existing deficiency. - A. Except as previously disclosed and acknowledged in writing to Lender, no Hazardous Substance is or will be located, stored or released on or in the Property. This restriction does not apply to small quantities of Hazardous Substances that are generally recognized to be appropriate for the normal use and maintenance of the Property.


