MEMORANDUM OF LEASE

This Memorandum of Lease is made on August 7th, 1998, by and between Halsted-Schubert Associates, an Illinois general partnership, and North Halsted Street Associates, an Illinois general partnership (collectively "Landlord"), and Chernin's Shoes, Inc., a Delaware corporation, formerly known as Harris Chernin, Inc., an Illinois corporation ("Tenant").

On November 22, 1991, Landlord and Tenant entered into that certain Lease ("Lease") for real estate located in Chicago Illinois, and legally described on Exhibit A attached hereto and made a part hereof ("Premises").

The Lease commenced on October 1, 1991 and expires on November 30, 1991, unless sooner terminated as provided in the Lease on terms and conditions more particularly described in the Lease. The Lease provides that Tenant has the option to extend the term of the Lease by ten (10) years so that the expiration date is November 30, 2011, and provided that Tenant exercises the foregoing option, that Tenant has a second option to extend the term of the Lease for another ten (10) years so that the expiration date is November 30, 2021.

Upon the termination of the Lease prior to its expiration, Landlord may record a "Notice of Termination of Lease." Upon the recording of the Notice of Termination of Lease, the Lease shall be conclusively presumed to have terminated on the date set forth in the Notice, unless Tenant shall file suit to prevent the termination of the Lease and record a lis pendens within sixty (60) days after the recording of the Notice, whereupon the Notice of Termination of Lease shall be ineffective until an agreement of the parties or court order to the contrary is made or entered.
