THIS SPECIAL AMENDMENT NO. 2 TO DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS, COVENANTS AND BY-LAWS FOR TOWNE SQUARE OF SKOKIE CONDOMINIUM ASSOCIATION is made and entered into by TOWNE SQUARE, L.L.C. as of this 28th day of September, 1998 ("Declarant").

#### **RECITALS:**

A. Declarant Recorded the Parlaration of Condominium Ownership and of Easements, Restrictions, Covenants and By-Laws for Towne Square of Skokie Condominium Association (the "Declaration") on May 9, 1997 in the Office of the Recorder of Deeds for Cook County, Illinois ("Office"), as Document No. 97330041 (the "Declaration").

B. Declarant also Recorded the following documents amending the Declaration:

- C. The Declaration, as amended and modified by the foregoing Amendments (the "Condominium Declaration"), subjected the Property legally described on Exhibit A attached hereto and made a part hereof to the Condominium Declaration and submitted it to the provisions of the Act.
- D. Declarant is the owner of Parking Space Numbers P-24C, P-25C and P-26C, which were subjected to the Condominium Declaration and submitted to the provisions of the Act pursuant to the Condominium Declaration. In accordance with Section 26 of the Act, Declarant desires to (i) transfer and assign Parking Space Number P-24C to Dwelling Unit 1-604, (ii) transfer and assign Parking Space Number P-25C to Dwelling Unit 1-504, and (iii) transfer and assign Parking Space Number P-26C to Dwelling Unit 1-206, by Recording this Special Amendment.
- E. Parking Space Numbers P-24C, P-25C and P-26C were not previously assigned by deed to any Unit.

F. The undivided interests in the Units are unaffected by the transfers described in Recital D above and they shall remain the same as set forth in the Condominium Declaration.

NOW THEREFORE, Declarant does hereby amend the Declaration as follows:

- 1. All terms used herein, if not otherwise defined herein, shall have the meanings set forth in the Declaration.
- 2. The Plat of Survey attached as Exhibit A to the Condominium Declaration is hereby amended, as shown on Exhibit Z attached hereto, to identify (a) Parking Space Number P-24C as assigned to Dwelling Unit 1-604; (b) Parking Space Number P-25C as assigned to Dwelling Unit 1-504; and (c) Parking Space Number P-26C as assigned to Dwelling Unit 1-206.
- 3. Exhibit B to the Condominium Declaration is hereby amended to provide that Parking Space Number P-24C is assigned to Dwelling Unit 1-604, Parking Space Number P-25C is assigned to Dwelling Unit 1-504, and Parking Space Number P-26C is assigned to Dwelling Unit 1-206.
  - 4. Except as herein an erded, the Condominium Declaration shall continue in full force and effect.
- 5. The undersigned hereby certify that a copy of Special Amendment No. 2 has been delivered to the Board of Managers of Towne Square of Skipping Condominium Association.


