MEMORANDUM OF SUBLEASE

This MEMORANDUM OF SUBLEASE is executed and delivered on this 13th day of October, 1998, to give notice that NuVisior Holdings L.L.C., an Illinois limited liability company ("Sublessor") and Monroe Corp., an Illinois corporation ("Sublessee") have entered into a certain Amendment to Second Sublease Agreement and Conversion to Sublease, dated the 13th day of October, 1998 ("Amendment to Second Sublease"). Said Amendment to Second Sublease amends and converts to a sublease a certain Second Sublease Agreement, dated July 1, 1994 ("Sublease"), entered into by and between Sublessor and Sublessee (collectively the "Sublease" and "Amendment to Second Sublease" are referred to as the "Sublease"), with respect to certain property known as the Monroe Nursing Center, located at 2829 South California Boulevard, Chicago, Illinois (the "Subleased Premises"), and legally described on Exhibit A attached hereto and made a part hereof.
