BALLOON LOAN MODIFICATION

This Balloon Loan Modification ("Modification,"), entered into effective as of the 1st day of JULY 1998 between ROBERT J O'MEARA JR AND SUE A.F. (2) the Balloon Note bearing the same date as, and secured by, the Security Instrument (the "Note") which covers the real and personal property described in the Security Instrument and defined in the Security Instrument as the "Property", located at 346 SOUTH BURTON, ARLINGTON HEIGHTS ILLINOIS 60005, the real property. described being set forth as follows:

To evidence the election by the Borrower of the CONDITIONAL RIGHT TO REFINANCE and Extension of Loan Terms as provided in the Balloon Note Addendum and Balloon Rider and to modify the terms of the Note and Security Instrument in accordance with such election, Borrower and Lender agree as follows (notwithstanding anything to contrary contained in the Note or Security Instrument):

- 1. The Borrowers are the owners of the Property.
- 2. As of JULY 1, 1998 the amount payable under the Note and Security Instrument (the "Unpaid Principal Balance") in U.S. \$169,761.24.

3. The Borrower promises to pay the Unpaid Principal Balance, plus interest, to the order of the Lender. Interest will be charged on the Unpaid Principal Balance at yearly rate of 7.625%, beginning JULY1, 1998. The Borrower promises to make monthly payments principal and interest of U. S. \$1,268.36 beginning on the 1st day of AUGUST 1998, and continuing thereafter on the same day of each succeding month until principal and interest are paid in full. If on JULY 1, 2023, (the "Modified Maturity Date"), the borrower still owes amounts under the Note and the Security Instrument, as amended by this modification, the Borrower will pay these amounts in full on the Modified Maturity Date.

The Borrower will make such payments at 4242 North Harlem Avenue Norridge IL 60634 or at such other place as the Lender may require.

- 4. The Borrower will comply with all other covenants, agreements, and requirements of the Note and the Security Instrument, including without limitation, the Borrower's covenants and agreements to make all payments of taxes, insurance premiuns, assessments, escrow items, impounds, and all other payments that the Borrower is obligated to make under the Security Instrument; however, all the terms and provisions of the Balloon Note Addendum and Balloon Rider are forever careful, null and void, as of the maturity date of the Note.
- 5. Nothing in this Modification shall be understood or construed to be a satisfaction or release in whole or in part of the Note and Security Instrumer. Except as otherwise specifically provided in this Modification, the Note and Security Instrument will remain unchanged and in full effect, and the Borrower and Lender will be bound by, and comply with, all of the terms and provisions thereof, at amended by this Modification.
