AMENDMENT TO MORTGAGE

THIS AMENDMENT TO MCRTGAGE ("this Amendment") is dated of the personally, but solely as Trustee under Trust Agreement dated October 28, 1997 and known as Trust No. 10-2166 ("Mortgagor") for the benefit of First Bank and Trust Company of Illinois ("Mortgagee").

Mortgagor is the owner in fee simple of that certain real estate in Cook County, Illinois legally described in Exhibit A attached hereto ("the Property").

Mortgagor and the beneficiaries of Mortgagor, Warren McElwain and Russell McElwain (the "Beneficiaries") entered into a certain Mortgage Note (the "Prior Note") as of January 29, 1998 in the principal sum of \$2,250,000 payable to Mortgagee.

Mortgagor and the Beneficiaries delivered an Amended and Restated Mortgage Note dated September 29, 1998 (the "Amended Note") to Mortgagee, in the principal sum of \$4,500,000, the terms of which note are incorporated herein by this reference.

Mortgagor, the Beneficiaries and Mortgagee desire to amend the terms of the Mortgage to reflect the terms set forth in the Amended Note.

- **Terms**. Where the terms of this Amendment conflict with the terms of the Mortgage, the terms of this Amendment shall control. In all other respects, the terms of the Mortgage shall remain in full force and effect.
 - 2. **Note.** As used in the Mortgage, the term "Note" shall refer to the Amended Note.
 - 3. **Principal Amount.** The Principal amount secured by the Mortgage is \$4,500,000.
- Maturity. The principal amount secured by the Mortgage shall be due and payable on June 30, 1999.
- Representations and Warranties. Mortgagor and each of the Beneficiaries hereby 5. remakes to Mortgagee each of the representations and warranties made by them in the Mortgage, and hereby agrees to be bound by all of the covenants and conditions therein.
