CITY OF CHICAGO, an Illinois municipal corporation ("Grantor"), in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, conveys and quitclaims to LAWNDALE CHRISTIAN DEVELOPMENT CORPORATION, ar Illinois not-for-profit corporation ("Grantee"), 3843 West Ogden, Chicago, Illinois 60623, pursuant to ordinance adopted by the City Council of the City of Chicago on June 14, 1995, all interest of Grantor in the real property legally identified and described on Exhibit A attached hereto ("Property").

This Quitclaim Deed is subject to the following express conditions and covenants which are a part of the consideration for the Property and which are to be taken and construed as running with the land and binding on the Grantee and its successors and assigns.

(16) months from the date of this Quitclaim Deed, and shall complete the rehabilitation within twenty-four (24) months from the date of this Quitclaim Deed. In the event that the Grantee breaches this covenant, the Grantor may re-enter the Property and revest title in the Grantor. The revesting of title in the Grantor shall not defeat or render invalid the lien of any mortgage created for the purpose of financing the rehabilitation of the Property. This covenant shall terminate upon

the issuance of a Certificate of Completion by the Grantor.

SECOND: The Grantee shall not sell, convey or assign the Property or any part thereof or any interest therein without the prior written approval of the Grantor, except that the Grantee may mortgage the Property for the purpose of financing the rehabilitation of the Property. In the event that the Grantee breaches this covenant, the Grantor may re-enter the Property and revest title in the Grantor. This covenant shall terminate upon the issuance of a Certificate of Completion by the Grantor.

THIRD: The Property shall be used predominantly for residential purposes for a period of not less than fifteen (15) years from the date of this Quitclaim Deed. The Grantee may not rent a home to a tenant if the household income of the home exceeds 80% of the Chicago Primary Metropolitan Statistical Area ("PMSA") median income. The Grantee may not sell a home to an owner-occupant if the household income of the home exceeds 120% of the PMSA median income. This covenant shall terminate fifteen (15) years from the date of this Quitclaim Deed.

FOURTH: The Grantee shall pay all real estate taxes and assessments on the Property when due. This covenant shall remain in effect without any limitation as to time.

FIFTH: The Grantee shall not discriminate upon the basis of race, color, religion, sex or national origin in the redevelopment, rehabilitation, sale, lease, rental, use or occupancy of the Property. This covenant shall remain in effect without any limitation as to time.
